### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Finger Slough: The Finger Slough is 7.6 acres. The Finger Slough was excavated as a linear industrial water feature in 1923 to serve the Long-Bell lumber mill for log conveyance, sorting and storage. Spoils dug from the Finger Slough were side cast and spread out on the adjoining land. The Finger Slough is an open water body it is not a part of a tributary system and is not considered a wetland. During flood conditions surface water in the finger slough outflows via a culvert into the dewatering pond located at its northern end. Surface water within the Dewatering Pond flows into the Black Lagoon via three side by side culverts located at the northern end of the pond. Surface water within the Black Lagoon outlets to the Perimeter Ditch to the North Tie Road via culvert, where water enters a pipe and flows to the Consolidated Diking and Improvement District (CDID) Ditch #3. From Ditch #3, surface water flows to the CDID Oregon Way Pump Station and is pumped via pipe to the Columbia River. In total the flow path from the Finger Slough to the Columbia River is approximately 9,500 linear feet. The Port manages and maintains the Finger Slough, the Dewatering Pond, Black Lagoon, and Perimeter Ditch as an integral part of their industrial stormwater treatment system under a stormwater management plan. The primary hydrologic sources for the Finger Slough are ground water, stormwater runoff, and precipitation. The duration of surface water flow out of the Finger Slough/Dewatering Pond varies depending upon annual precipitation levels and trends. Some years there is no flow. There is no flow during the summer and fall. The Finger Slough is bordered by industrial development to the west, south, and east, while the Dewatering Pond, Fibre Way, railroad, and Black Lagoon are located on the north side of Finger Slough. The Natural Resources Conservation Service (NRC) Soil Survey maps the Finger Slough as water while the surrounding area is mapped as Pilchuck loamy fine sand, a non-hydric soil in Cowlitz County, Washington. The Finger Slough is being used for stormwater retention and detention and does not support interstate or foreign commerce. Since the Finger Slough only connects downstream during flood conditions, the Corps has determined that the Finger Slough is an isolated open water body.

Dewatering Pond: The Dewatering Pond is 0.07 acre and was constructed in 2009. Based on Google Earth Pro aerial imagery the dewatering pond historically would have been located within the boundaries of the Finger Slough. However, sometime between July 23, 2000 and June 15, 2003 this area of the Finger Slough was filled and converted to uplands. The dewatering pond was constructed to manage discharges during the construction of the underground rail dump pits for the Export Grain terminal. In accordance with the preamble to the 1986 regulatory definition of Waters of the U.S., the dewatering pond is an artificial pond constructed in uplands and is not considered a water of the United States.

Black Lagoon: The Black Lagoon is 0.06 acre and was constructed in 2002 in association with the Industrial Rail Corridor and the Fibre Way Grade Separation. This project took place in the same location as the original Fibre Way bisection. To address water flow from the Finger Slough, the project included a new stormwater conveyance system connecting the Finger Slough to the Black Lagoon. The new conveyance system consisted of three underground parallel pipes running north from the Finger Slough to the Black Lagoon. In accordance with the preamble to the 1986 regulatory definition of Waters of the U.S., the Black Lagoon is an artificial pond constructed in uplands and is not considered a water of the United States.

Perimeter Ditch: The Perimeter Ditch is 0.04 acre. Water within the Perimeter Ditch flows through a culvert and outlets into Ditch A. Vegetation within the ditch consists primarily of reed canary grass and there are no clear vegetation lines. Scour marks, wrack deposits, or erosion lines were not observed within the ditch. Based upon historic aerial imagery the ditch was excavated in uplands. In accordance with the preamble to the 1986 regulatory definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the United States
