(b) General Flow Relationship with Non-TNW:

Aerial imagery depicts visible wetland saturation within the Review Area and visible saturation/flow through a series of drainage ditches to the City of Dallas stormwater management system which discharges into Rickreall Creek.

(c) Wetland Adjacency Determination with Non-TNW:

Discrete wetland hydrologic connection. Explain:

Wetland 1: Wetland 1 is located in the western portion of the Review Area and flows south into a drainage ditch located within the central portion of the southern neighbors' property, under their driveways, and into the City of Dallas stormwater management system. From there, water flows south for approximately 0.21 miles within the stormwater management system to discharge into Rickreall Creek.

Wetlands 2: Wetland 2 is located within the eastern portion of the Review Area and flows south and into a drainage depression for approximately 0.11 mile until it flows into a catchbasin for the City of Dallas stormwater management system. From there, water flows east and south for approximately 0.40 miles within the stormwater management system until it discharges into Rickreall Creek. Ditches 1 and 2 were delineated within the boundaries of Wetland 2. As discussed above, Ditch 3 is the portion of Ditch 2 in uplands. The wetland delineation indicates these ditches do not support an Ordinary High Water Mark (OHWM) and, therefore, are considered a portion of Wetland 2.

Wetland 3 was constructed in uplands around 2010 as a stormwater treatment wetland. Wetland 3 flows east through Ditch 3 and into Wetland 2. The applicant was able to procure a National Pollutant Discharge Elimination System permit for the construction of the church, however, the documentation did not demonstrate that this stormwater wetland was designed and constructed to meet the requirements of the CWA. As such, the Corps has determined Wetland 3 does not meet the Waste Treatment System Exclusion at 33 CFR 328.3(b). Wetland 3 is not an artificial lake or pond constructed in uplands, it is not an artificial reflecting or ornamental body of water constructed for aesthetic reasons, nor is it a water filled depressed incidental to construction. Therefore, Wetland 3 is not considered a preamble water as defined in the preamble to the 1986 regulatory definition of waters of the U.S. Because Wetland 3 meets the 3 parameters necessary to determine the feature a wetland and does not meet any exemptions or exclusions, we have determined it is a wetland with an unbroken connection to Rickreall Creek.

Summarize overall biological, chemical and physical functions being performed: Wetland 1, 2, and 3, all act as natural filters to filter stormwater inputs from the Trinity Lutheran Church and other upslope developments. Wetland 1, 2, and 3 trap and store surface water flow and provide habitat for terrestrial species such as rodents, insects, and amphibians.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
