C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Portions of Wetland 1 are palustrine forested and portions are palustrine emergent. The primary source of hydrology is precipitation and runoff from surrounding areas of higher elevation and ground water. Wetland 1 drains south and out of the Review Area through a stormwater drain under Third Avenue. The storm drain flows to a RPW-ditch located on the north side of W 5th avenue. The ditch exhibits surface water in a Google Earth aerial dated July 22,2021. From there, the stormwater flows west through the ditch and is culverted under Wallis Street and South Bertelson Road. The ditch flows to the west until highway 569 and the ditch turns north crossing below a railroad bridge and turning west flowing below a Highway 569 bridge. The ditch flows into Amazon Creek. Amazon Creek flows into the Long Tom River, which flows into the Willamette River, a traditional navigable water listed on the Navigable Riverways within the State of Oregon dated October 1993. The flow path as described from the Review Area to the Willamette River is approximately 29.58 miles as measured in Google Earth. Wetland 1 would have a direct hydrologic connection through the stormwater drain and ditch to the Willamette River. Wetland 1 and similarly situated wetlands with direct hydrologic connections would provide pollutants and nutrients downstream to through the storm drain and ditch system to the Amazon Creek, into the Long Tom River, and into the Willamette River. Wetland 1 has more than a speculative and insubstantial nexus downstream to the Willamette River.

ADDITIONAL COMMENTS TO SUPPORT JD: The 1.6-acre Review Area consists of Tax lot 3000 and portions of the immediately adjacent West 3rd Avenue road right-of-way on Assessor map Township 17 South, Range 04 West, Section 27-44, Willamette Meridian. The Review Area is situated atop an alluvial terrace landform historically dissected by a northwest sloping swale feature. A majority of the feature supports a stand of *Fraxinus latifolia* trees with scattered *Fraxinus* saplings, *Rosa* spp., *Symphoricarpos albus*, and *Rubus armeniacus* in the understory. Herbaceous vegetation is primarily dominated by *Schedonorus arundinacea* and *Alopecurus pratensis* which transitions to *Juncus effuses* in the topographically low portions. The easternmost third is dominated by herbaceous species *Schedonorus arundinacea* and *Alopecurus pratensis*. Soil within the review area is mapped by NRCS as Awbrig silty clay loam, a hydric soil.

On April 27, 2022, we coordinated this JD with EPA Region 10. On May 2, 2022, the EPA concurred with our findings.
