C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A: This is a 0.006 acre wetland is a palustrine emergent wetland located within a vacant lot. The wetland is surrounded by uplands. The nearest known waterway is an unnamed tributary of Fanno Creek and is located to the northwest approximately 1720 feet away. There are no surface water drainages that connect Wetland A to the nearest waterway. The primary sources of hydrology for Wetland A are precipitation and groundwater. During extreme flood conditions Wetland A would not overflow and connect to the any waterway. Based on historic aerial imagery, the site was developed for residential buildings prior to 1994. In 2007, the site was cleared and the lot has remained vacant. The soils within this portion of the Review Area are mapped as 37B Quatama Loam, a non-hydric soil group. Vegetation within the site currently consists of hydrophytic vegetation including toad rush (facultative wetland), velvetgrass (facultative), and colonial bentgrass (facultative). Wetland A is not located within a mapped floodplain. The Review Area is surrounded by commercial developments to the east and west and roadways to the north and south. Wetland A is located on private property and is not connected to interstate or foreign commerce. Based on the lack of connection or adjacency to any jurisdictional waters, the Corps has determined Wetland A is an isolated water.

Ditches 1, 2, and 3: The water within these ditches flow through culverts and into the City of Tigard water management system. Vegetation within these ditches consists of upland and facultative-upland species and therefore did not meet the definition of wetlands. These ditches do not contain bed and bank and did not show evidence of an ordinary high water mark. Flow within the ditches is considered Non-RPW. Based on historic aerial imagery and the soil surveys, these ditches were excavated from uplands. The soils where these ditches are located is mapped as 37B Quatama Loam, a non-hydric soil group. In accordance with the preamble to the 1986 Regulatory Definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the US.
