No surface water flows were observed in the ditches during the wetland delineation field visit in September 2021. Four wastewater lagoons and a**

**sludge storage lagoon are part of a wastewater treatment system were observed within the review area and are not a water of the U.S. These waters identified are preamble waters and are not jurisdictional.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

No surface water flow in Ditch 1 and Ditch 3 have been observed in aerial imagery and no erosional features were observed within the ditches. Wastewater treatment lagoons and a sludge storage lagoon were also observed within the review area. Waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of Clean Water Act are not waters of the U.S. There is no indication the wastewater treatment lagoons were constructed in wetlands at the time of construction. These waters are preamble waters that are not jurisdictional.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** No coordination with the EPA is required for non-jurisdictional preamble waters.
