C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland 1 is a 0.17-acre palustrine emergent wetland within the southern part of Review Area. The wetland is confined between the base of the adjacent slopes and the Interstate 5 Highway roadway prism. The dominant vegetation is Himalayan blackberry (*Rubus armeniacus*). The primary source of hydrology is from a stormwater conveyance pipe located west of the wetland which drains the adjacent residential development and rain. The wetland boundary follows along the base of the slopes and the I-5 roadway embankment.

Stream 1 is an intermittent stream that outfalls from a 12” concrete outfall located in the west part of the study area. The drainage begins at the top of a slope, draining north down a step hillslope into Wetland 1. The drainage has a substrate comprised of boulder and cobble. The drain water comes from adjacent upland developments.

There are no surface drainage features between Stream 1 and Wetland 1 and the Willamette River, which is the nearest Water of the U.S. The site is bordered on the southeast by Interstate 5 with no observed or recorded outfalls traveling under I-5 for surface water at this location. The site is bordered on other sides by residential development. The Willamette River is located approximately 0.28 miles away. The site has a lowest elevation point of 140 feet in the wetland. The Willamette River at Portland currently measures at 6.5 feet. During extreme floods the Willamette River would not reach Stream 1 or Wetland 1, nor during extreme floods would the Stream 1 and Wetland 1 drain to the Willamette River. The wetland sits in a depression surrounded by steep hills. The land between the Wetland 1 and Stream 1 and the Willamette River consists of residential development, commercial development, and freeways. Soil surveys map the area as Urban Land. Wetland 1 and Stream 1 are not located within a floodplain.

Wetland 1 and Stream 1 are not used by interstate or foreign travelers for recreational purposes. There is a lack of habitat and resources of special significance, as well as bird and wildlife species onsite which would attract travelers. There is no shellfish or fish production on this site. There is no industrial, agricultural, or silviculture use of the site of which good would be sold from the site to interstate or foreign entities.
