C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Claggett Creek is a perennial tributary as classified in the National Hydrography Dataset, and indirectly flows to the Willamette River. The tributary is located approximately 185ft due west outside of the review area for this jurisdictional determination that Wetland A abuts. This tributary is a prominent and distinct feature on LIDAR imagery and has visible surface saturation year-round in Google Earth imagery. The feature flows to the northwest for approximately 2.7 miles where it drains into Clear Lake, and then flows an additional 4 miles to mile 74 of the Willamette River. The Willamette River is

recognized by USACE Portland District as a navigable water pursuant to the USACE's 1994 list of Navigable Riverways within the State of Oregon to river mile 183.2..

Wetland A is a 0.739 palustrine emergent wetland within the Review Area that extends westward outside of the review area. The nearest known waterway is Claggett Creek at a distance of 185ft from the Review Area and Wetland A. Wetland A is hydrologically connected to Claggett Creek (RPW) as stated on the wetland delineation completed by the consultant. The primary sources of hydrology for Wetland A are precipitation, groundwater, and overbank flooding from Claggett Creek. NRCS Soil mapping indicates hydric soil (Bashaw Clay) extending from the review area into the RPW. Local Wetlands Inventory provided by Oregon Department of State Lands indicate a wetland of similar shape and acreage which extends from the review area to RPW. Google Earth imagery shows visible surface saturation outside of the review area towards the RPW. Wetland A is located within a FEMA floodplain. LIDAR and topographic mapping further support the wetlands abutting the RPW.
