C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A: Wetland A is a 1.06-acre palustrine forested wetland within the Review Area that contains a linear swale feature and areas of seasonal ponding. The nearest known waterway is the West Middle Fork of Pringle Creek, which is a heavily modified intermittent stream located approximately 615ft to the north of Wetland A, as measured by Google Earth. The primary sources of hydrology for Wetland A are precipitation and stormwater from the upgradient residential subdivision located to the South and West of the Review Area. Stormwater enters Wetland A from three culverts; one located along the western boundary of the Review Area, and two located along the southern boundary, near the intersection of Landau Street SE and Pikes Pass Street SE. The swale does not exhibit a defined channel, nor a consistent surface water connection to downstream waters and therefore is not recognized as a tributary or relatively permanent water. Only during extreme events would Wetland A exhibit sheet flow towards a culvert located at the northern boundary of the Review Area, however, there is no channelized feature, nor a shallow subsurface connection between Wetland A and the culvert. Under normal conditions, surface water within Wetland A infiltrates the soil before reaching the culvert. The plant community between Wetland A and the culvert is dominated by non-hydrophytes. The soils in this portion of the Review Area are mapped as McAlpin silty clay loam, a non-hydric soil group, indicating the lack of a shallow subsurface connection. Wetland A is located on private property and is not connected to interstate or foreign commerce. The delineated boundaries of the wetland do not extend north to the culvert and there are no drainage features connecting Wetland A to the culvert; therefore Wetland A is isolated and does not contribute a hydrologic connection to a relatively permanent water or navigable water.

Ditch 1: Ditch 1 does not possess a streambed, streambanks, or ordinary high water mark indicators. Surface water flow within the ditch is considered ephemeral and non-RPW. Ditch 1 flows through a culvert at Landau Street SE and is then conveyed to the City of Salem’s stormwater system. Based on historic aerial imagery and the soil surveys, Ditch 1 was excavated from uplands. The soils where Ditch 1 is located is mapped as Nekia silty clay loam (NeB), a non-hydric soil group. In accordance with the preamble to the 1986 Regulatory Definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the US.
