### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

Wetland A: Wetland A is a 1.52-acre palustrine emergent wetland that is seasonally flooded/saturated. The primary sources of hydrology are groundwater, precipitation, and irrigation. The nearest known waterway is an unnamed tributary to Mill Creek. The unnamed tributary is located on the northside of Parr Road to the northwest and is approximately 0.15 mile away as measured by Google Earth. Wetland A is not located within a floodplain. There is no evidence of surface water channel or topographic feature that would outflow from Wetland A to the nearest known tributary. There is no evidence of shallow subsurface flow between Wetland A and the nearest known tributary. Soils within the Review Area are mapped as Amity silt loam and Woodburn silt loam, both are non-hydric soils. Hydrology within the wetland would infiltrate into the ground or evaporate. There is no evidence that the wetland supports interstate or foreign commerce. The Corps has determined Wetland A to be isolated.

Wetland B: Wetland B is a 0.16-acre palustrine wetland within the Review Area and extends outside of the Review Area to the southwest. The primary sources of hydrology are groundwater, precipitation, and irrigation. The nearest known waterway is an unnamed tributary to Mill Creek. The unnamed tributary is located on the northside of Parr Road to the northwest and is approximately 0.15 mile away as measured by Google Earth. Wetland B is not located within a floodplain. There is no evidence of surface water channel or topographic feature that would outflow from Wetland B to the nearest known tributary. Wetland B is not located within a floodplain. There is no evidence of shallow subsurface flow between Wetland B and the nearest known tributary. Soils within the Review Area are mapped as Amity silt loam and Woodburn silt loam, both are non-hydric soils. Hydrology within the wetland would infiltrate into the ground or evaporate. There is no evidence that the wetland supports interstate or foreign commerce. The Corps has determined Wetland B to be isolated.
