C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **Wetland A and B are east-west oriented forested scrub-shrub wetlands located in the middle of the review area. Wetland A is 0.23 acre, Wetland B is 0.03 acre. The wetlands are bisected by a man-made ditch measuring 0.04 acre. Rand Road lies to the east of the review area, residential fill pads situated to the north and south, and an open field to the west. Surface water hydrology within Wetlands A and B are received from precipitation, groundwater, and overland sheet flow. Wetlands A and B would provide hydrologic input to Ditch. There was no evidence of surface water outflows from Wetland A, B, or the Ditch to Henderson Creek which is the nearest mapped waterway on U.S. Geological Survey maps, located 0.15 mile to the west of the review area, however this feature is not visible in aerial imagery. There is a hill shown on the lidar maps at the west end on the ditch. Between the review area and Henderson Creek is a large open field mapped as NWI Maps as uplands. Henderson Creek does not inundate Wetlands A, B, or the Ditch during high water events. The Corps did not identify information demonstrating Wetlands A, B, or the Ditch possess a shallow-subsurface hydrologic surface connection to Henderson Creek. The soil type within the review area is Rockford stony loam, 8-12% slopes (non-hydric) and Rockford very stony loam, 0-30% slopes (non-hydric).**

The wetlands and ditch are approximately 0.4 mile from the Columbia River, the nearest TNW. The review area is not located in a floodplain as recognized by the Federal Emergency Management Agency.

Wetlands A, B, and ditch do not contain habitat, resources, birds, or wildlife that would attract interstate or foreign visitors for recreational purposes. The site does not contain fish or shellfish which could be taken or sold in interstate or foreign commerce. The site does not have industrial, agricultural, or silviculture of which products could be sold in interstate or foreign commerce.
