C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

D-01 within the review area is approximately 500 linear feet long and 4 feet wide, totaling approximately 0.007 acre in size. Hyrophytic vegetation and wetland hydrology were absent during the June 2021 sample plots. June 2021 precipitation was above normal; however, March through May 2021 precipitation was below normal and outside of the normal range. The site is constructed in mapped uplands and non-hydric soils. In accordance with the preamble to the 1986 Regulatory Definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the US.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Project is located within the Willamette Valley. The historic and current land uses include agriculture, commercial businesses, industrial land, and rural residential. Lands adjacent to the review area are seasonally maintained by the City of Salem and the State of Oregon as highway right-of-way. The review area situated southwest of Aumsville Highway is entirely within one Mill Creek subwatershed and the Lower Mill Creek (6th level HUC 170900070204)

Roads, buildings, fills and grading, and ditches for drainage associated with these practices have likely affected the geographic size or the hydroperiod of wetlands and other waters. Mapped NWI features that intersect 62nd Ave. SE, Deer Park Drive, Highway 22, and Kuebler Blvd. have been culverted under the roadways, or were permanently impacted in the past from road construction. In 2004, the area was part of a larger wetland delineation project performed by Parametrix (ODSL# WD03-0262). The ODSL authorization for removal and/or fill, and grading activity for the Mill Creek Corporate Center, included the area east of Kuebler Blvd., south of Mill Creek Drive, and north of Turner Road (DSL Permit No. 34119-FP).

This project was coordinated with EPA on 22 June 22. EPA responded on 29 June 22 suggesting review as a preamble water excluded under the 1986 Regulations. On 01 July 2022 the AJD was updated as a preamble excluded water.
