C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A: Wetland A is a 0.05-acre palustrine emergent wetland belonging to the depressional hydrogeomorphic (HGM) sub classification and is located within an agricultural field in the Review Area. The nearest known waterway is an unnamed intermittent tributary to Little Butte Creek, located approximately 425 feet to the southwest outside of the Review Area. The perimeter of Wetland A was excavated in the 1970’s to serve as an irrigation pond and was subsequently filled circa 1998. The primary source of hydrology for Wetland A is precipitation and surface runoff from the upland area to the northeast. Surface runoff was likely greater in the past due to irrigation from a remnant orchard and flood waters from an Eagle Point Irrigation District (EPID) canal which transported water along the eastern boundary of the Review Area. The canal was piped circa 2010, and is no longer providing diversions, reverting previously identified hydric areas to upland. The soils within this portion of the Review Area are mapped as Padigan Clay (139A), a hydric soil group. Hydrophytic vegetation was mapped within Wetland A and was dominated by grasses, primarily *Alopecurus pratensis*, with weedy vegetation such as *Dipsacus fullonum* and *Lotus corniculatus* also present throughout the wetland. Based on topography, surface runoff from Wetland A would sheet flow to the southwest towards a roadside swale and culvert. However, as evidenced by the numerous plots in the provided Wetland Delineation report, there is no channelized feature, nor a shallow subsurface connection between Wetland A and the roadside swale and culvert. Wetland A is not located within a mapped floodplain and would only overflow to the nearest waterway during extreme flood events. Wetland A is not connected to interstate or foreign commerce. Based on the lack of connection or adjacency to any jurisdictional waters, the Corps has determined Wetland A is an isolated water.

Ditch 1: Ditch 1 is a roadside ditch which primarily drains the adjacent upland area. Ditch 1 does not possess a streambed, streambanks, or ordinary high water mark indicators. Surface water flow within the ditch is considered ephemeral and non-RPW. Ditch 1 flows through a culvert at Robert Trent Jones Boulevard and is then conveyed to an unnamed intermittent tributary to Little Butte Creek. Based on historic aerial imagery and the soil surveys, Ditch 1 was excavated from uplands. The soils where Ditch 1 is located are mapped as Carney clay (27b), a non-hydric soil group. In accordance with the preamble to the 1986 Regulatory Definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the US.

Ditch 2: Ditch 2 consists of a network of ditches which drain a surrounding gravel lot used for RV’s. Ditch 2 does not possess a streambed, streambanks, or ordinary high water mark indicators. Surface water flow within the ditch is considered ephemeral and non-RPW. Ditch 2 does not have any outlet to nearby aquatic resources. Based on historic aerial imagery and the soil surveys, Ditch 2 was excavated from uplands. The soils where Ditch 2 is located are mapped as Carney clay (27b), a non-hydric soil group. In accordance with the preamble to the 1986 Regulatory Definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the US.

Ditch 3: Ditch 3 consists of a network of abandoned irrigation canals which were solely intended to carry water from the Eagle Point Irrigation District (EPID) canal. The canal was piped circa 2010 and is therefore no longer provides diversions. Ditch 3 does not possess a streambed, streambanks, or ordinary high water mark indicators. Surface water flow within the ditch is considered ephemeral and non-RPW. Ditch 3 does not have any outlet to nearby aquatic resources. The soils where Ditch 3 is located are mapped as Carney clay (27b), a non-hydric soil group. Based on historic aerial imagery and the soil surveys, Ditch 3 was excavated from uplands. In accordance with the preamble to the 1986 Regulatory Definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the US.
