C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): Pond 1 is an open water feature. The current conditions of the Review Area are not accurately reflected on the 2020 USGS topographic map for Eagle Point (1:24k), or in the USGS’ National Hydrography Dataset (NHD) and U.S. Fish and Wildlife’s (USFWS) National Wetland Inventory. These maps and databases depict surface water connections between Pond 1 and other open water features to the southwest and northeast of the Review Area. Google Earth aerial images from 1994 to 2020 do not show these surface water connections. The applicant and consultant confirmed that these surface water connections are not present and that Pond 1 does not drain into a subsurface pipe. The Corps determined that the pond is an isolated feature with no connection to downstream waters of the U.S. or a TNW.

Pond 1 was excavated between 1958 and 1974 as shown on historical U.S. Geological Survey topographic maps. Blue line streams were not mapped within the Review Area or in its’ vicinity during this time period. A historic aerial image of the Review Area taken circa 1950 was provided by the applicant and does not show streams on the site or in its’ immediate vicinity. The Review Area is underlain by Agate-Winlo soil which is typical of vernal pool complexes, including wetlands and upland mounds between aquatic features. While this soil type is considered hydric, the Corps determined the pond was not excavated in a historic waterway or wetland because this soil type can occur in uplands and there were no other indications of a water at this location.

The pond contains open water and algae, and is surrounded by maple (*Acer* sp.) and apple (*Malus* sp.) trees. Wetlands do not occur within the Review Area. Currently Pond 1 functions only for aesthetic purposes. It collects rainfall and is sometimes fed by an underground pipe that brings water from an uphill pond to the north of the Review Area and into Pond 1. In the western corner of the pond, there is a rock wall. This structure does not function to transport water, nor does it dam water because it is not flush with the pond’s bottom elevation. There is no outlet for water to and water levels in the pond can be artificially controlled with hand pumps.

The pond has not reached the top of bank in the past five years or more. There is no hydrological connection between Pond 1 and the pond to the southwest of the Review Area. Further, there is no hydrological connection between Pond 1 and Military Slough to provide a connection a downstream TNW. Construction of Pond 1 removed any hardpan layer that may have been present and previously allowed for surface and subsurface lateral flows from the pond to nearby tributaries. The Corps determined that Pond 1 is an isolated feature that does not fall under the jurisdiction of Section 404 of the Clean Water Act.
