C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland C: Wetland C is a 0.10-acre palustrine emergent wetland belonging to the Flats hydrogeomorphic (HGM) sub classification, and is located in a shallow depression formed due to past use as a staging area for quarried material and/or cut timber. The primary sources for hydrology are precipitation and surface runoff from adjacent uplands, both of which are seasonally dependent. The dominant vegetation within Wetland C is reed canary grass (*Phalaris arundinacea*, FACW). The soils within the vicinity of Wetland C are mapped as Alstony gravelly loam (4E), a non-hydric soil group. Wetland C is not identified in the National Wetland Inventory. Based on topography, any sheetflow during extreme events would flow from Wetland C to the east towards Beaver Falls Road, however there are no defined surface drainage features in the area indicating consistent flow from Wetland C. Wetland C is not located within a mapped floodplain, and there is no evidence of a shallow subsurface connection to other aquatic resources within the Review Area. Wetland C does not contribute a hydrologic connection to a relatively permanent water, nor a navigable water, and therefore has been determined to be an isolated non-jurisdictional water.

Ditch 1: Ditch 1 is a roadside ditch which is adjacent to Beaver Falls road. The primary sources for hydrology are precipitation and surface runoff from adjacent uplands. Ditch 1 does not possess a streambed, streambanks, or ordinary high water mark indicators. Surface water flow within the ditch is considered ephemeral and non-RPW. Ditch 1 flows through a culvert at Beaver Falls Road and is then conveyed to a terrace above Beaver Creek. The soils where Ditch 1 is located are mapped as Alstony gravelly loam (4E), a non-hydric soil group. Based on historic aerial imagery and the soil surveys, Ditch 1 was excavated from uplands. In accordance with the preamble to the 1986 Regulatory Definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the US.

Drainage 1: Drainage 1 is a steep (>45%) and narrow (~1ft) erosional feature extending north to south in the Review Area. The primary sources for hydrology are precipitation and surface runoff from upland areas which extend north beyond the Review Area. Surface water flow within Drainage 1 is ephemeral, and under normal conditions, surface water infiltrates the soil as the slope decreases towards the south of the Review Area. Drainage 1 does not possess a streambed, streambanks, or ordinary high water mark indicators. Drainage 1 exhibits sparse wetland vegetation and shows no indication of wetland hydrology or wetland soils. Based on a lack of hydrologic indicators and connection to a relatively permanent water, Drainage 2 is not a water of the U.S.

Drainage 2: Drainage 2 is a steep (>45%) and narrow (3-4ft) erosional feature extending north to south in the Review Area. The primary sources for hydrology are precipitation and surface runoff from upland areas which extend north beyond the Review Area. Surface water flow within Drainage 2 is ephemeral, and under normal conditions, surface water infiltrates the soil as the slope decreases towards the south of the Review Area. Drainage 2 does not possess a streambed, streambanks, or ordinary high water mark indicators. Drainage 2 exhibits sparse wetland vegetation and shows no indication of wetland hydrology or wetland soils. Based on a lack of hydrologic indicators and connection to a relatively permanent water, Drainage 2 is not a water of the U.S.
