C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

EPH-01 through 05 are ephemeral channels. The channels within the Review Area are not considered tributaries as they do not flow directly or indirectly into a TNW. The drainage flows to the north until the topography flattens at the Boardman Bombing Range; at this location the drainage features are no longer present or mapped in the National Hydrography Dataset. The Corps did not identify a surface water outflow channel which leaves the boundaries of the Boardman Bombing Range. ;The area is surrounded by irrigated agricultural lands and a highway to the north. The overland sheetflow surface water flow path identified by the Corps is consistent with U.S. Geological Survey stream stats rain drop mapping tool which also does not document surface water outflow leaving the Boardman Bombing Range. Based on this information the Corps has determined EPH-01 through 05 are isolated. The channels are ephemeral drainages and there is no evidence to suggest that the channels are used to support interstate or foreign commerce or used by foreign travelers.
