C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Google Earth Pro shows the RPW with surface water in imagery dates June 22, 2017, September 2020, and April 15, 2021. The RPW flows into the Trask River, a listed navigable waterway on the Corps Portland District list of Navigable Riverways Within the State of Oregon dated October 1993 to river mile 3.5 with the head denoted at the U.S. Highway 101 bridge crossing. The unnamed tributary's surface water connection with the Trask River occurs approximately 0.4 mile upstream of this location.

Wetland A: Wetland A is located in the southeast portion of the Review Area. Wetland A is palustrine emergent wetland dominated by spreading bent and creeping buttercup grasses. The U.S. Department of Agriculture Natural Resources Conservation Service soil map denotes the area as Urban land-Udorthents complex, a non-hydric soil in Tillamook County, Oregon. There are no surface water drainages between Wetland A and another aquatic resources. The nearest known tributary to Wetland A is an unnamed tributary to the Trask River which is located approximately 0.27 mile to the northwest of the Review Area, as measured by Google Earth Pro. Wetland A is separated from other nearby tributaries through commercial development, airport runways, and agricultural land. During the most extreme precipitation and surface water flow events, surface water within Wetland A would not reach the unnamed tributary but would flow into the Upland Ditch 4, which is designed to infiltrate water and is discussed below. Wetland A is located adjacent an airfield and is not used to support interstate or foreign commerce or used by foreign travelers. Wetland A is considered isolated.

Upland Ditches 1-6: The facility, parking lot, road, and upland ditches were constructed within the Review Area in 2012. At the time of construction, the ditches were located within the uplands. The bottom of the ditches are filled with rock and designed for water to infiltrate to avoid standing water that could attract wildlife hazards. There is no surface water outflow from the ditches to downstream surface waters; surface water within the ditches infiltrates on-site within the Review Area. On-site photographs taken on April 5, 2022 show the ditches as dry. In accordance with the preamble to the 1986 regulatory definition of Waters of the U.S., ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the United States.
