C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland 1 is a vegetated ditch, which drains from the south and north towards a drywall in the central portion of the ditch. By dry well it is a concrete buried box with outlet holes surrounded by drain rock. The nearest tributary is South Scappoose Creek located approximately 320 linear feet to the north and west, as measured by Google Earth. The area between Wetland 1 and the creek is developed land used by Cascade Concrete Products. The area is mapped Sifton Loam, a non-hydric soil. The wetland is located on developed land and used to treat stormwater runoff. Based on historic topo graphic maps and aerials Wetland 1 was constructed in the uplands. In accordance with the preamble to the 1986 regulatory definition of Waters of the U.S., artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing are generally not considered waters of the U.S.
