C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A: Wetland A is a 0.12-acre palustrine emergent wetland. Wetland A is approximately 350 linear feet from Bear Creek. There is a roadway and waste treatment pond between Wetland A and Bear Creek. Wetland A is bordered by developed roads. There are no surface water drainages or pipes connected Wetland A with another aquatic resource. The area is mapped as Aloha silt loam, a non-hydric soil. In extreme events it is unlikely that Wetland A would overtop its banks and flow into Bear Creek. Wetland A does not provide the desired habitat to local salamanders and amphibians (Clouded Salamander, Cascade Torrent Salamander, and Northern Red-Legged Frog), therefore Wetland A does not share an ecological connection with Bear Creek. Wetland A is located within a wastewater treatment center and is not used to support interstate or foreign commerce or used by foreign travelers. Wetland A is considered isolated.

Wetland B: Wetland B is a 0.72-acre palustrine emergent wetland. Wetland B is approximately 370 linear feet from Bear Creek. There is a roadway and waste treatment pond between Wetland A and Bear Creek. Wetland B is bordered by developed roads. There is an access road that separates Wetland B and Wetland C (located outside of Review Area) to the east. The access road does not have a culvert or pipe that connects Wetland B to Wetland C. There are no surface water drainages or pipes connected Wetland B with another aquatic resource. The area is mapped as Aloha silt loam, a non-hydric soil. In extreme events Wetland B may flow from its delineated boundaries and discharge into Wetland C (located outside of the Review Area) which abuts Bear Creek. Wetland B does not provide the desired habitat to local salamanders and amphibians (Clouded Salamander, Cascade Torrent Salamander, and Northern Red-Legged Frog), therefore Wetland B does not share an ecological connection with Bear Creek. Wetland B is located within a wastewater treatment center and is not used to support interstate or foreign commerce or used by foreign travelers. Wetland B is considered isolated.

Wetland D: Wetland D is a 1.92-acre palustrine emergent wetland. Wetland D is approximately 1,450 linear feet from Bear Creek. Wetland D is bordered by berm and waste treatment ponds to the north and uplands. There are no other mapped aquatic features in NHD near Wetland D and the Oregon Department of Geology and Mineral Industries (DOGAMI) lidar does not indicate the presence of a linear ditch in the area. There is a rise in topography between Wetland D and highway 211 to the south. There are no surface water drainages or pipes connected Wetland D with another aquatic resource. The area is mapped as Aloha silt loam and Amity silt loam, both are considered non-hydric soil. In extreme events it is unlikely that Wetland D would overtop its banks and flow into Bear Creek. Wetland D is located within a wastewater treatment center and is not used to support interstate or foreign commerce or used by foreign travelers. Wetland D is considered isolated.

Wetland E: Wetland E is a 0.24-acre palustrine emergent wetland. Wetland E is approximately 1,250 linear feet from Bear Creek. Wetland E is bordered by uplands to the north, west and south, and a berm and waste treatment pond to the east. There are no other mapped aquatic features in NHD near Wetland D and DOGAMI lidar does not indicate the presence of a linear ditch in the area. There are no surface water drainages or pipes connected Wetland E with another aquatic resource. The area is mapped as Aloha silt loam, a non-hydric soil. In extreme events it is unlikely that Wetland E would overtop its banks and flow into Bear Creek. Wetland E is located within a wastewater treatment center and is not used to support interstate or foreign commerce or used by foreign travelers. Wetland E is considered isolated.
