C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **Roadside Ditch, Drainage Ditch B3, Drainage Ditch R3, and Drainage Ditch A2 were constructed as part of the Hillsboro Airport stormwater management system and are used to relocate water off the runways. These drainages were constructed in uplands and drain uplands. The ditches are seasonally saturated due to water running off the airport runways and taxiways. The vegetation is managed to reduce wildlife attractants within airport property. Vegetation consists of mainly non-native FAC species. Boundaries were delineated based on topography and boundaries of wetland vegetation and soils. Wetland hydrology was met due to secondary indicators (geomorphic position and FAC-neutral test). The ditches display inconsistent ordinary high water marks and may have non-RPW stormwater flow during the rainy season. The adjacent upland soils lack hydrology indicators. Soils are mapped as urban lands within the review area and Amity silt loam is the primary soil type in the vicinity of the review area. The culvert inlets are set slightly above ground level, which causes water to saturate the soils before the water rises above the inlet and enters the stormwater system. Because the ditches are surrounded by uplands and are components of the airport's stormwater management system, the Corps has determined these ditches were constructed in uplands and drain only uplands and therefore are considered non-jurisdictional surface water features.**
