Wetland A is connected in the northwest to Wetland 2, which is located offsite and is bound by gravel road to the north, and uplands to the west, with no hydrological connection to a Relatively Permanent Water (RPW) or**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 - Other: (explain, if not covered above): **Wetland A is a PEM wetland with its southeastern border located at the toe slope of a hillside. Wetland A was connected in the northwest to Wetland 2, which has been developed and was located outside of the study area. Wetland 2 was delineated 14 October 2019 under Oregon Department of State Lands Wetland Delineation # 2019-0391. At that time a roadside swale was shown at the northern boundary of Wetland 2, which was located alongside the residence driveway and not hydrologically connected to another water. The nearest RPW to Wetland A (and offsite Wetland 2) is a tributary to Rock Creek, located approximately 0.35 mile to the southwest. From the point of the RPW convergence with Rock Creek, Rock Creek flows approximately 0.5 mile to the Clackamas River, a TNW. The hydrology sources for Wetland A are a seasonally high groundwater table, precipitation, and subsurface flow from the adjacent uplands upslope. Topography of the site has a northwestern aspect with 5 to 10 percent slopes throughout most of the site, gaining elevation to approximately 20 percent slopes in the southeastern corner. The following soil units are mapped within the study area, according to the Natural Resources Conservation Service (NRCS) Clackamas County Area Soil Survey Map: Cascade silt loam, 3 to 8 percent slopes (Unit 13B), Non-hydric, with no hydric inclusions; Cascade silt loam, 8 to 15 percent slopes (Unit 13C), Non-hydric, with no hydric inclusions; Delena silt loam, 3 to 12 percent slopes (Unit 30C), Hydric; Powell silt loam, 0 to 8 percent slopes (Unit 70B), Non-hydric, with no hydric inclusion. Hydric soils mapped in the northern portion of the study area were determined to be upland and had been recently modified with construction fill. Soils in the wetland are low chroma (chroma of 2 or less) displaying common distinct redoximorphic features, meeting hydric soil indicators F6 Redox Dark Surface underlain by a depleted matrix, meeting hydric soil indicator F3 Depleted Matrix. Wetland A is dominated by sweet vernal grass (Facultative Upland Plants (FACU)), meadow foxtail (Facultative Plants (FAC)), tall false rye grass (FAC), and common velvet grass (FAC), with lesser amounts of creeping buttercup (FAC) and garden bird’s-foot-trefoil (FAC). The wetland boundary is well defined based on the subtle change in the landform from a concave lower elevation in the wetland to a higher elevation convex landform in upland. This change in topography coincides with a slight change in the vegetation community. There was a greater amount of creeping buttercup (FAC) present in the wetland in comparison to the surrounding upland. The adjacent upland lacked hydric soils and indicators of wetland hydrology. The nearest RPW is approximately 0.35 mile away, where there would be no occurrence of overflow during high water events that would enter into Wetland A. Wetland A is located in an area that is being commercially developed 0.05 mile to the west, and 0.10 mile to the southwest. The land upslope of Wetland A to the southeast and northeast is former farmland, where located directly east of the wetland is a residence. Wetland A does not possess an interstate commerce connection. There is no interstate use by interstate and/or foreign travelers for recreational purposes since there is a lack of resources of special significance at this location. There are no bird or wildlife species that would attract interstate or foreign travelers; there are no fish or shellfish which could be taken or sold in interstate or foreign commerce; and there are no industrial, agriculture and silviculture purposes which could be sold in interstate/foreign commerce at this location.**
