### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Wetland A: This 0.30 acre wetland is a palustrine emergent wetland located within a vacant lot. The wetland is surrounded by uplands. The nearest known waterway is an unnamed tributary of Butternut Creek and is located to the west approximately 1,046 feet away. There are no surface water drainages that connect Wetland A to the nearest waterway. The primary sources of hydrology for Wetland A are stormwater runoff from impervious surfaces, precipitation, and groundwater. Based on historic aerial imagery, the site has been undeveloped since 1994. The soils within this portion of the Review Area are mapped as 3 – Amity Silt Loam, a non-hydric soil group with a drainage class of “somewhat poorly drained”. Hydrophytic vegetation is present within Wetland A primarily consisting of Oregon Ash (facultative wetland), western crabapple (facultative wetland), and English hawthorne (facultative), Himalayan blackberry (facultative), and velvet grass (facultative). Additionally, hydric soils and multiple secondary indicators of hydrology were present. Wetland A is not located within a mapped floodplain. The Review Area is surrounded by residential/commercial developments and infrastructure. Wetland A is located on private property and is not connected to interstate or foreign commerce. There is a roadside ditch associated with SW Farmington Road located south of the wetland. The roadside ditch is higher in elevation, located outside of the review area, is man-made, and flows into the city stormwater treatment system. There are no observed surface water connections between Wetland A and the ditch. A wetland data point (DP-1) between Wetland A and the ditch reflected there is hydrophytic vegetation present (facultative, facultative upland, and upland), but found no indicators of hydrology between the wetland and the ditch, nor any hydric soil indicators. Any flows in Wetland A would be from the south side of the site to the north side of the site based upon elevation contours. Based upon the lack of hydrological connections or adjacency to any jurisdictional waters, the Corps has determined Wetland A is an isolated water.
