### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):**

- If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.
- Review area included isolated waters with no substantial nexus to interstate (or foreign) commerce.
  - Prior to the Jan 2001 Supreme Court decision in “*SWANCC*,” the review area would have been regulated based solely on the “Migratory Bird Rule” (MBR).
- Waters do not meet the “Significant Nexus” standard, where such a finding is required for jurisdiction. Explain: **The Corps determined Wetlands 1-4 are isolated waters with no significant nexus to a downstream TNW. Wetland 1 abuts Ditch A. Wetland 2 abuts Ditch C. Wetlands 3-5 are adjacent to Ditch D. Ditches A, C, and D convey irrigation water that is diverted from the Deschutes River to agricultural properties in the Swalley Irrigation District (SID) service area. The National Hydrography Dataset (NHD) shows that Ditch D flows to the north outside the Review Area and splits into two channels. One channel flows to the northwest and terminates in an upland area between Scenic Drive and Highway 20. The second channel flows to the northeast and terminates in an upland area along Old Bend – Redmond Highway. The consultant spoke with SID staff to confirm that irrigation water within Ditch D does not reconnect to a manmade or natural tributary downstream of the Review Area. The SID explained that irrigation water is only discharged into agricultural properties. The consultant described the communication in an email to the Corps dated September 26, 2022. The Corps determined there is no connection between Wetlands 1-4 and a downstream TNW via surface water flow (see below for additional details). The closest tributary to the Review Area is the Deschutes River which is 1 mile to the west. To the west of the Review Area, the elevation rises roughly 20 feet which would prevent a subsurface hydrologic connection between the wetlands and TNW. In conclusion, the Corps determined there is no physical, chemical, or biological connection between the wetlands and TNW.**
- Other: (explain, if not covered above): **The Corps determined that Pond 1 is a non-jurisdictional, open water feature. The hydrological source for the pond is Ditch D, in addition to incidental precipitation and runoff from the surrounding rural properties. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986, states that non-jurisdictional waters include "Artificial lakes and ponds, including water storage reservoirs and farm, irrigation, stock watering, and log cleaning ponds, constructed or excavated in upland or in non-jurisdictional waters". The Corps reviewed USGS topographic maps from 1929 to 2020 and did not find blue line streams in the location of the pond. In addition, the pond is underlain by non-hydric, well drained soil (Deskamp loamy sand, 0-3% slopes). As such, there is no evidence that the pond was constructed in a tributary or wetland.**

**As described above, Pond 1 collects water from Ditch D. Ditches A-C convey water from the pond to uplands in the Review Area for irrigation purposes. There is no downstream hydrologic connection between the ditches and a TNW or other tributary. The flow path for Ditch D is described above, and this feature also terminates in uplands. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986, states that jurisdictional tributaries must contribute surface water flow to a TNW. In conclusion, the Corps determined that Ditches A-D are non-jurisdictional.**
