SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. Summarize rationale supporting determination: The Review Area is within the northern portion of the Portland International Airport (PDX) located south of Marine Drive, and west of the Port of Portland Fire Department, in Portland, Oregon. Marine Drive is an active levee system that serves as a man-made barrier between the Columbia River to the north, and PDX runways/infrastructure to the south. The Columbia River is located north and the Columbia Slough is located south of the Review Area, both are recognized by the Corps Portland District as TNWs near the Review Area.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: Four wetlands identified as Wetland A, B, C, and D, are located within a Review Area measuring approximately 105 acres in size within the boundaries of PDX, south of Marine Drive and the Columbia River. The entire Review Area is located within the 100 year floodplain of the Columbia River and Columbia Slough as mapped by the Federal Emergency Management Agency and is currently protected by a levee system. The wetland hydrology for three of the wetlands (Wetland A, C, and D) are captured by the PDX stormwater conveyance system that eventually discharges to the Columbia River to the north of the Review Area, and to the Columbia Slough, south of the Review Area. Wetland B has formed overtime and is considered adjacent to the Columbia River and Columbia Slough. Wetland A is approximately 886 linear feet from the Columbia River, Wetland B is approximately 1,557 linear feet from the Columbia River, Wetland C is approximately 1,902 linear feet from the Columbia River, and Wetland D is approximately 1,817 linear feet from the Columbia River.

CWA jurisdiction exists over all TNWs and over all wetlands adjacent to TNWs including over adjacent wetlands that do not have a continuous surface connect to TNWs. For a wetland adjacent to a TNW, adjacent is defined as “bordering, neighboring or contiguous.” Wetlands separated from other waters of the U.S. by manmade dikes or barriers, natural river berms, beach dunes, and the like are also adjacent wetlands.

The criteria for a wetland to be considered adjacent to a TNW or Relatively Permanent Water is met if one of following three criteria is satisfied: 1) there is an unbroken surface or shallow sub-surface connection to jurisdictional waters; this hydrologic connection maybe intermittent, 2) the wetland is physically separated from jurisdictional waters by man-made dikes or barriers, natural river berms, beach dunes, and the like, or 3) the proximity of the wetland to a jurisdictional water is reasonably close, supporting the science-based inference that such wetlands have an ecological interconnection with jurisdictional waters.

The four wetlands within the Review Area meet the adjacency criteria as it relates to wetlands adjacent to a TNW. Wetland A, C, and D maintain a hydrologic surface connection with the stormwater system within the Review Area which provides an unbroken surface and subsurface piped connection to discharge points in the Columbia River and Columbia Slough. The physical separation between the four wetlands and the Columbia River and Columbia Slough are man-made levees and berms protecting the airport and other infrastructure. The proximity of wetlands to the Columbia River and Columbia Slough are ecologically interconnected and are reasonably close to infer an ecological interconnection without a case specific demonstration.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
