C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **The project site is approximately 637.4 acres. There are two delineated resources in the review area, D-001 and D-002, and have been determined not jurisdictional according to regulations in 33 CFR Part 328. D-001 and D-002 do not have any hydrologic connections to any waterways or waterbodies, according to the TRC Wetland and Waterbody Delineation Report – Jefferson Solar Project. D-001 is a 614.12 square feet roadside ditch with a width of 1.5 feet, a depth of 0.5 feet, and a 1% slope. D-001 starts about halfway up SW Elbe Dr and runs straight to SW Monroe Lane. As the ditch approaches SW Monroe Lane, it flattens out into uplands. "Photo 1" provided by the applicant in a Request for Additional Information received on January 4, 2023, shows D-001. Based on the provided ground level photograph and remote resources, the ditch is in uplands, ephemeral and is relatively flat. D-002 is an ephemeral 50.72 square feet ditch with a width of 1.5 feet, a depth of 0.4 feet and a 15% slope. D-002 is a roadside ditch that parallels Highway 97 as shown in Figure 6 of the TRC Wetland and Waterbody Delineation Report - Jefferson Solar Project. There are no additional aquatic features within the review area as indicated by TRC in a Request for Additional Information received on January 4, 2023 and the TRC Wetland and the Waterbody Delineation Report – Jefferson Solar Project. D-001 and D-002 were constructed in uplands, drain only uplands, and do not carry relatively permanent flow. D-001 and D-002 do not have any bed, bank, or ordinary high watermark characteristics according to TRC Wetland and the Waterbody Delineation Report – Jefferson Solar Project. The resources in the review area meet the description of Waters Generally Not Considered Jurisdictional, per the preamble of the November 13, 1986, Federal Register (51 FR, 41217) (“preamble waters”), which include non-tidal drainage and irrigation ditches excavated on dry land. The resources within the review area do not meet the definition of WOTUS in 33 CFR 328.3(a).**
