This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**328. This ditch was constructed in uplands, drains only in uplands, and does not carry any relatively or non-relatively permanent flow. The Roadside Ditch has no established bed and bank. Therefore, it does not meet the definition of a tributary. The Roadside Ditch in the Review Area meets the description of Waters Generally Not Considered Jurisdictional, which were "clarified" in the preamble of November 13, 1986, Federal Register (51 FR, 41217) ("preamble waters"), which includes non-tidal drainage and irrigation ditches excavated on dry land. This surface water feature within the Review Area does not meet the definition of waters of the U.S. in 33 CFR 328.3(a).**

**The Wetland is a paulstrine emergent/scrub-shrub wetland in the slope/flats hydrogeomorphic class totaling 1.3 acres and extends off the Review Area to the west. The Wetland has no surface-water connection to another wetland and is not connected to a tributary system. There is no information to indicate the Wetland exhibits a downstream connection to any waterway. The Wetland would not overflow or connect to a waterway during extreme flooding events. This depressional wetland is surrounded by uplands and located in a depressional bowl with no outlet. The source of hydrology for the wetland is direct precipitation and groundwater. The Wetland has no outflow. Dominant hydrophytic vegetation found within the Wetland included reed canarygrass (*Phalaris arundinacea*) and Douglas spirea (*Spirea douglasii*); other vegetation included rose (*Rosa pisocarpa*), Scouler willow (*Salix scouleriana*) and Oregon ash. The Wetland possess a redox dark surface hydric soil indicator. According to Gable Road Wetland Delineation, December 2022 and Photos A and C, standing water and shallowing ponding was observed in the Wetland. Soils were saturated to the surface. The Wetland is an isolated waters with no substantial nexus to interstate (or foreign commerce). The Corps has determined the Wetland is not a water of the U.S.**
