C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide data and rationale indicating that tributary is perennial: Johnson Creek is a perennial waterway which is located approximately 215 feet south of the Corps Review Area. Johnson Creek is not evaluated in this AJD but provides the hydrologic connection for Ravine 1, Ravine 2, and Wetland 1 to Johnson Creek as discussed in Section III.D.4 below to a TNW. Johnson Creek flows west for approximately 3,000 feet before crossing under Beach Loop Road. Johnson Creek then flows west for approximately 800 feet where it enters the Pacific Ocean. The lower reach of Johnson Creek is tidally influenced and is by definition a TNW.

U.S. Geological Survey (USGS) StreamStats basin report for the drainage basin encompassing Johnson Creek identifies surface water flow present within Johnson Creek every month of the calendar year. Surface water ponding is visible in the May 9, 2019 Google Earth Pro aerial image. Johnson Creek is recognized as a solid blue line in USGS quadrangle maps south of the Review Area which denotes Johnson Creek is a perennial surface water feature. Johnson Creek possesses a streambed, streambanks, and ordinary high water mark south of the review area.

The northern portion of the Review Area is comprised of Blacklock fine sandy loam, 3 to 7 percent slope soils. The southern portion of the Review Area is comprised of Bullards sandy loam, 30 to 50 percent slope soils. Chetco silty clay loam soils are found south of the Review Area where Johnson Creek is located. The Blacklock and Checto soils are recognized as hydric soils in Coos County, Oregon per the U.S. Department of Agriculture (USDA) Natural Resources Conservation Service (NRCS).

Ravine 1 is a 0.003-acre palustrine forested (PFO) slope wetland located in the southwest portion of the Review Area. Ravine 1 possesses an unbroken hydrologic surface connection with Wetland 1, a 0.014-acre PFO flats wetland located along the southern boundary of the Review Area.

Ravine 2 is a 0.006-acre PFO slope wetland located in the southwest portion of the Review Area. Ravine 2 possesses an unbroken hydrologic surface connection with Wetland 1, a 0.014-acre PFO flats wetland located along the southern boundary of the Review Area.

Wetland 1 possesses an unbroken surface connection to Johnson Creek located approximately 215 linear feet south of the Review Area.

Ravine 1, Ravine 2, and Wetland 1 are one contiguous wetland which were delineated based on hydrogeomorphic class types in the delineation.
