Rationale for determination: The irrigation canal identified within the review area is a tributary to Crooked Creek that carries a relatively permanent flow and does not solely drain uplands. This canal is part of the Medford Irrigation District. Historical imagery dates the construction of the canal back to at least the late 1970's. Furthermore, aerial imagery depicts surface flow within the canal predominantly during the growing season from May to September. Due to the connectivity of this aquatic feature with downstream tributaries, it has been determined that this unnamed irrigation canal satisfies the definition of an (a)(3)(i) tributary that meets the relatively permanent standard.



Additional comments to support AJD: As documented in the applicant's wetland delineation, the review area appears to have been utilized historically for agricultural purposes, dating back to the 1970's and thus has been highly manipulated. The only features consistently present in the historic aerial imagery are the irrigation canal and Wetland 1. There are no other wetlands or non-wetlands present on the site in the historic aerial imagery dating back to the 1970's.
