#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**Significant Nexus Determinations for Wetland A and Wetland C**

**Wetland A** is hydrologically isolated from the nearest tributary to a traditionally navigable waterway. The water is physically situated approximately 900 feet from Rock Creek. There is no surface or shallow subsurface connection to convey or contribute waters, sediment, organic matter, food resources, or other nutrients. The wetland is perched on basalt bedrock. Precipitation from adjacent uplands flows through shallow subsurface to this low area and ponds for a duration sufficient to establish hydric soil indicators before leaving through evaporation or evapotranspiration. The wetland is mostly flat and linear in shape with gentle side slopes. Vegetation consists of Oregon ash, and black cottonwood. Shrub layer is composed of young Oregon ash, Douglas spirea, willow, and rose. Herbaceous layer is mostly reed canarygrass, bentgrass, and sedges. The wetland is approximately 1.01 acres in size, unchanged since 2009 based on 2015 re-evaluation. There is no Significant Nexus to a Traditionally Navigable Water.

**Wetland C** is located approximately 150 feet horizontal distance from Rock Creek. There is a basaltic ridge to the west separating the wetland from the tributary, ranging in height from 150 to 210 feet above sea level. Another ridge to the east of the wetland ranges from approximately 160 feet to 190 feet in height. The basaltic bedrock would effectively preclude shallow subsurface connection between the wetland and Rock Creek. There would be no exchange of hydrology, sediment, organic matter, food resources, or other nutrients. Approximately 0.47 acre of the 1.3-acre wetland is located on the subject property. There is no Significant Nexus to a Traditionally Navigable Water.
