Wetland A is a 0.67 acre palustrine scrub-shrub (PSS) and palustrine emergent (PEM) depressional wetland. Hydrophytic vegetation is dominated by black cottonwood (*Populus balsamifera* spp. *trichocarpa*), narrow-leaf willow (*Salix exigua*), Sitka willow (*Salix sitchensis*), reed canary grass (*Phalaris arundinacea*), and slough sledge (*Carex obnupta*). Soils displayed the depleted matrix hydric soil indicator (F3). Hydrology indicators included the primary indicators of high water table (A2) and saturation (A3) and the secondary indicators of water-stained leaves (B9), drainage patterns (B10), geomorphic position (D2), and FAC-neutral test (D5).

Uplands in the study area consist of steep slopes and fill material. The transition from wetland to upland was generally typified by a marked change in plant community, a rise in elevation, or an increase in soil compaction. The upland forest area was dominated by black cottonwood and Himalayan blackberry (*Rubus ameniacus*). Uplands across the rest of the property were dominated by tall fescue (*Schedonorus arundinaceus*), sweet vernal grass (*Anthoxanthum odoratum*), and ox-eye daisy (*Leucanthemum vulgare*). Sample plots in upland areas did not display hydric soil indicators and lacked wetland hydrology indicators.

Wetland A does not have a connection to the ditch located north of the study area in the railroad right-of-way. There is a berm between the wetland and the ditch to the north. The ditch to the north is offsite of the property and was likely created from the fill being placed for the railroad track. The ditch is not consistent along the northern part of the property, it is interspersed with upland areas and eventually disappears on the western edge of the property.

The ditch to the north of this site flows to the east in this section based on site topography. The railroad ditch drains into a storm manhole located south of the tracks near the north east corner of the site. The height of the outflow drain is a minimum of 1-foot above the ground below it, so at least a foot of water would have to collect in the area before it could drain into the manhole. The flow is then piped north to a second manhole north of the tracks, and then into the Wal-Mart site, with an outfall into an open conveyance that joins the mainstem of Fairview Creek to the northwest. Fairview Creek flows to Fairview Lake and then to the Columbia Slough.

Historically the site contained buildings in aerial photographs from 1990. The buildings were in existence until 1999. All buildings and roads were removed from the site and the site was graded and compacted by machinery. The Oregon Department of Transportation used the site as a staging area during road improvements projects in 1998 to 2000.

The site is located outside of the 500 year floodplain. Due to the surrounding development and roadways, there is very little, if any utilization of the onsite wetlands by animals that would utilize nearby creeks or rivers. Wading, water, and migratory bird utilization was not noted on site during the Corps site visit. The wetland would not have more than a speculative or insubstantial effect on the chemical, physical, and biological integrity of the Columbia River. The wetland does not support a link to interstate or foreign commerce, and are not currently used, nor are they likely to be used, by interstate or foreign travelers for recreational or other purposes. The Corps does not have information documenting interstate/foreign recreational or commercial uses at the site in its current condition. Current site conditions would not support the presence of fish or shellfish that could be taken and sold in interstate or foreign commerce. Based on the nature and size of the wetlands, it is unlikely it would support industrial purposes by industries in interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
