Explain: **There is one 0.04 acre PEM wetland in the review area, referred to as Wetland 2. The parcel is protected by levees along the northern and western boundaries. The general topography of the site is gently sloped from north to south with some undulating hills throughout, creating small depressions. Field meadow-foxtail (*Alopecurus pratensis*)**

is the dominant on-site vegetation. The subject site appears to be actively hayed throughout most of the area. Parallel rows of silt fence have been installed to keep Canadian geese and other wildlife from utilizing the site, due to proximity of the airport. The site has been in agricultural use since the 1930's. Surface water temporarily ponds in Wetland 2, which originates from a 10-inch pile protruding from below the gravel yard on the Pacific Boats, Inc. property to the north of the wetland, creating a small drainage from the pipe to the wetland. Stormwater runoff runs from the parking area into the field creating the wetland. The wetland is at the lowest topographic point of the site. Water evaporates or seeps into the soil from the wetland as it can not drain offsite.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
