### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):**

- Other: (explain, if not covered above): **Wetland A is a depressional wetland which has developed in a historic irrigation ditch. Wetland A abuts Ditch A. Ditch A is an irrigation ditch that does not convey irrigation flow any longer. Water is conveyed from Ditch A to Wetland A only. Water does not flow out of Ditch A and is not conveyed off of the site through the ditch or any other aquatic resource. Irrigation has been abandoned on this site since circa 1998, and Wetland A and Ditch A are remnant depressional features where water continues to pool from localized overland runoff. Pooling of water in these aquatic resources appears to be precipitation, groundwater, and overland flow driven.**

Wetland A and Ditch A do not meet the criteria of adjacency to traditionally navigable waters (TNW), relatively permanent waters (RPW), or non-relatively permanent waters (non-RPW). The nearest TNW is the Rogue River; the nearest RPW is Bear Creek; and the nearest non-RPW is an Unnamed Tributary to Bear Creek. These waters are further detailed in the Additional Comments to Support JD in Section IV.

During a wetland delineation dated March 2015 (field investigation conducted on February 10, 2015), the water table was not observed within a soil sample to a 17-inch depth for sampling point T2-P1. A lack of an observed water table during the growing season which indicates there is no shallow subsurface connection to either Wetland A or Ditch A. In addition, Wetland A and Ditch A lack an unbroken hydrologic connection to either the Rogue River, Bear Creek or the unnamed tributary to Bear Creek.

Other than topography, there is no indication of physical barriers, either natural or artificial, between Wetland A and Ditch A immediately to either the Rogue River, Bear Creek or the Unnamed Tributary to Bear Creek. An extensive road network is located within the area and there is no evidence the presence of a stormwater conveyance.

The nearest distance to either Bear Creek or the Unnamed Tributary to Bear Creek is at least 0.3 miles or 1,584 feet and no ecological interconnection may be observed in Wetland A and Ditch A with either Bear Creek or the Unnamed Tributary to Bear Creek.

It should be noted that ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are generally not waters of the United States because they are not tributaries or they do not have a significant nexus to downstream traditional navigable waters.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland A is located within the Larson Creek-Bear Creek watershed (HUC12: 171003080110). The source of hydrology for Ditch A and Wetland A appears to be precipitation, groundwater, and overland flow driven. Intervening land use is predominantly agricultural (60% of land cover). The taxlot where Wetland A and Ditch A are located is on the urban fringe of the City of Central Point. Residential (30% of land cover) and commercial (10% of land cover) land uses occur within the vicinity of the taxlot. Vegetation in the region is dominated by grasses with limited and sparsely forested areas.

Aerial imagery, the National Hydrography Dataset, and Topographic maps detail the location of the nearest waters of the United States. The nearest traditionally navigable water is the Rogue River. The Rogue River is recognized by the U.S. Army Corps of Engineers, Portland District, as a navigable water to river mile (RM) 27.1. The Rogue River's Clean Water Act 404 traditionally navigable water (404 TNW) limits extend from at RM 27.1 to RM 157.5. Bear Creek flows into the Rogue River at RM 127. Wetland A is geographically situated between Bear Creek and an unnamed tributary to Bear Creek. The nearest down-gradient RPW to both Wetland A and Ditch A is Bear Creek, which is located approximately 0.4 miles to the south of the study area (shortest line distance), near RM 5 of approximately 28.8 total river miles. The nearest down-gradient relatively non-RPW is an Unnamed Tributary to Bear Creek located approximately 0.3 miles to the north of the study area near the intersection of Bebbard Rd. and Green Valley Way at approximate RM 1.6 of approximately 2 total river miles. The Unnamed Tributary to Bear Creek is an ephemeral tributary (RM 1.2 to RM 1.6) which becomes an intermittent tributary (RM 0 to RM 1.2) prior to flowing into Bear Creek at RM 3.5.

Natural Resources Conservation Service (NRCS) soil mapping indicates the soils within the study area are comprised of Agate-Winlo complex, Gregory silty clay loam, Kerby loam, Kubli loam, and Medford silty clay loam. These soils are hydric, according to the NRCS Hydric Soils List for the "Jackson County Area, Oregon, Parts of Jackson and Klamath Counties."

LiDAR imagery indicates overland flow from extreme storm/flood conditions would pool in adjacent taxlots where isolated ditches and ponds would capture and detain any potential runoff. LiDAR and aerial imagery indicate there is no direct or indirect connection from the aquatic resources identified in the study area to either Bear Creek or the Unnamed Tributary to Bear Creek, the nearest waters of the U.S.

The Federal Emergency Management Agency (FEMA) Floodrate Insurance Map (FIRM) map for the site in question indicates the study area is located in an area outside of the 100-year floodplain.

Wetland A provides small amounts of wetland habitat appropriate for migratory bird species, however, the wetland would not attract interstate or foreign recreational commerce due to wetland's small size and land setting lacking access to recreational visitors.

On March 15, 2017 the Corps coordinated this JD with EPA Region 10 and Corps HQ. On March 30, 2017, the EPA concurred with our findings while providing comments on the JD. Corps HQ did not provide any response within the required timelines.
