C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetlands shown in the wetland delineation are not water treatment facilities or have any flows found to continue to back to Larson Creek. Wetland A appears to be receiving stormwater from a nearby housing development and Wetland B and C are next to the golf course where the area is flood irrigated and no flows come out of the depressional boundaries. The vegetation and soils do not support the wetland boundaries extending beyond the lines shown in the maps. There is no direct hydrological, chemical or physical connection of wetland A, B, or C to Larson Creek or to Bear Creek. Wetland A is located approximately 600 feet from Larson Creek and is 5 feet in elevation above the creek. Wetlands B and C are located approximately 500 feet from Larson Creek and are located approximately 5 feet in elevation above the creek as well. Flooding in Larson Creek shown in a recent flood study map developed by Jackson County does not reflect flows reaching Wetland A, B, or C. In a 100 year event level flood, the flood elevation backs up into these areas, but it also backs up into the upland developed areas surrounding the site due to a boxed culvert located downstream that is sized more appropriately for a 25 year event flood. In the 25 year event flood Larson Creek would rise 1 foot above the ordinary high water mark and not reach Wetland A, B, or C. Therefore, Wetland A, B, and C are hydrologically isolated and have no chemical, physical, or biological connectivity to Larson Creek.
