C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A (0.42 acre): Wetland A is an artificially created wetland. Wetland A is in a small depression that was formed by the creation of the golf course, but the course was never extended into this area.. The southern edge of Wetland A ends at the base of an approximately 5ft tall berm located on golf course property. There was no visual evidence that Wetland A drains into any other wetlands or tributaries. There is no drain at the base of the berm. Wetland A is approximately 300ft from Wetland B. Wetland A is 1-2 river miles from the Tualatin River. The concave contour of Wetland A and the golf course berm prevents drainage into any other wetlands or tributaries. No wildlife usage was noted onsite.

Wetland B (.04 acre): Wetland B is an artificially created wetland. Wetland B is in a depression that was formed by creation of the golf course, but the course was never extended into this area.. There are no "as-built" drawings for the golf course on record. There was no visual evidence that Wetland B drains into any other wetlands or tributaries. There is a 5ft berm adjacent to the western edge of Wetland B that separated Wetland B from the golf course. An offsite berm on a private property (private property) lies immediately north of Wetland B. Wetland B is approximately 300ft from Wetland A. Wetland B is 1-2 river miles from the Tualatin River. The concave contour of Wetland B and the offsite berm prevents drainage into any other wetlands or tributaries.

Other: (explain, if not covered above): Irrigation Pond: An artificially created, elevated, plastic lined irrigation pond is located along the southern edge of the wetland. There is no drainage in or out of the irrigation pond.

Wetland A is a palustrine emergent wetland with a seasonal saturated water regime that is dominated by *Rumex crispus* (FAC), *Alopecurus pratensis* (FAC), *Poa species* (FAC), *Schedonorus arundinaceus* (tall fescue, FAC), and *Spiraea douglasii* (FACW). Hydric soil indicators include depleted matrix and redox dark surface but is in an area that is mapped non-hydric soil. Wetland Hydrology Indicators include high water table and saturation, and surface water present. The source of hydrology is precipitation and overland flow from the surrounding uplands. Wetland A extends past the study area boundary into the Parklane Golf Course. The southern edge of Wetland A ends at the base of an approximately 5ft tall berm located on golf course property. There is no drain at the base of the berm. The concave contour of Wetland A and the golf course berm prevents drainage into any other wetlands or tributaries.

Wetland B (.04 acre): Wetland B is an artificially created wetland. Wetland B is in a depression that was formed by creation of the golf course. There are no “as-built” drawings for the golf course on record. Primary source of hydrology appears to be precipitation and overland flow from surrounding uplands. The wetland is dominated by *Alopecurus pratensis*, (meadow foxtail) FAC. Hydric soil indicator of depleted matrix and wetland hydrology indicator of high water table and saturation but is in an area that is mapped non-hydric soil. There was no visual evidence that Wetland B drains into any other wetlands or tributaries. There is a 5ft berm adjacent to the western edge of Wetland B that separated Wetland B from the golf course. An offsite berm on a private property (private property) lies immediately north of Wetland B. The concave contour of Wetland B and the offsite berm prevents drainage into any other wetlands or tributaries.

Not jurisdictional pond:

Irrigation Pond: An artificially created, elevated, plastic lined irrigation pond is located along the southern edge of the site. There is no drainage in or out of the irrigation pond.
