C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:.

The 0.33 acre wetland is located in the southeast corner of the 318 acre study area adjacent to Camp Creek Road on a butte approximately 2.3 miles south of the Dry River as the crow flies. Change in elevation is approximately 900 feet. A review of topography shows a lack of any direct connection to the intermittent Dry River channel. Review of aerial photography within the study area shows the wetland area surrounded by sparse sagebrush steppe plant community and bare surface soils with established livestock trails. Wetland vegetation surrounding the stock tank, or cistern, and along approximately 100 feet of Camp Creek Road roadside ditch abutting the cistern is limited to two common sedge and cattail species. Precipitation amounts during the three month period prior to delineation peaked at 0.07 inches. The delineation identifies one ephemeral stream channel downslope of the cistern that loses definition within the study area; there is no continuous surface connection to jurisdictional water from the wetland.

The channel is described as shallow, poorly defined, and non-contiguous. Soils identified are well drained, non-hydric Dester sandy loam which consist of moderately deep, well drained soils that formed in volcanic ash over old sediments weathered from lava rock. There is no significant nexus between the study area and waters of the United States because there are no wetland functions that would affect jurisdictional water such as flood storage volume, flood flow alteration, flow maintenance, sediment trapping, or recreation. Alterations to the wetland would have no effect on groundwater recharge or discharge. Chemical functions, such as pollutant filtering, nutrient cycling and organic carbon export and retention would not be such that there would be a discernable affect to jurisdictional waters elsewhere in the hydrographic unit. Biological functions are unlikely to be affected as nesting, feeding and vertebrate spawning are highly unlikely to occur within the wetland due to livestock use although access to the open water source of the cistern itself could provide a water source for avian species.

The 0.33 acre wetland is isolated because there is no surface connection to any jurisdictional water.
