C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A is located in the southern corner of the site, within a subtle depression topographically. The wetland is constrained by upland terraces and an offsite residential development. Wetland A is Cowardin classified as Palustrine, Emergent, Seasonally Flooded/Saturated (PEME) and has a Oregon Hydrogeomorphic classification of Depression.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The 11.41-acre review area located at 3350 NE Portland Road, Salem, Marion County, Oregon, was delineated on July 1, 2016 and September 28, 2016. A 1.4-acre Wetland A is located in the southern corner of the site and is entirely within the review area. Wetland A is mapped based on slight topographic breaks corresponding to subtle changes in vegetation and underlying soils along the west and north portion. The south and eastern portion have a more distinct topographic breaks associated with spoils piles and/or property boundaries to adjacent residential lawns.

Vegetation within Wetland A is dominated by non-native facultative species such as tall fescue (*Schedonorus arundinacea*), bentgrass (*Agrostis capillaris*), and narrowleaf plantain (*Plantago lanceolata*) with scattered seedlings of Oregon white oak (*Quercus garryana*), Oregon ash (*Fraxinus latifolia*), common hawthorn (*Crataegus monogyna*), Himalayan blackberry (*Rubus armeniacus*) and California blackberry (*Rubus ursinus*). Vegetation within Wetland A satisfies the Dominance Test for hydrophytic vegetation; due to the rather marginal community, however, the Prevalence Index (PI) is not satisfied. In contrast, adjacent uplands support a higher establishment of upland species catsear (*Hypochaeris radicata*), bishop's lace (*Daucus carota*), California Blackberry (*Rubus ursinus*), and sweet vernal grass (*Anthoxanthum odoratum*).

Precipitation and runoff from adjacent upland terraces is the sole hydrological input within Wetland A due to surrounding development. No evidence of inundation within the landform was found; the field team did not observe water marks, sediment deposits, surface soil cracking, algal mat/crust formation or water stained leaves. Wetland A lacked primary indicator's (i.e., surface water (A1), high water table (A2), and Saturation (A3)), however; this was not sufficient evidence to disqualify the aquatic resources as wetland due to the late season field investigation. In place of primary hydrologic indicators, the wetland delineator relied on presence of secondary indicators coupled with established hydrophytic vegetation communities and hydric soils. Wetland A satisfies the technical requirements outlined in the 1987 Corps of Engineers Wetlands Delineation Manual and the Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Western Mountains, Valleys and Coasts Region (Version 2.0) to qualify as wetland.

Despite being mapped as moderately well drained Woodburn silt loam series, the feature contains silty clay loam soils with varying amounts of redoximorphic feature formation throughout the upper portion of the profile. Soils within the depressional wetland qualify for Redox Dark Surface (F6) and/or the Depleted Below Dark Surface (A11) hydric soil indicator. Adjacent uplands, in contrast, lack sufficiently dark matrix colors (10YR 3/3).

Historic manipulations within the review area include agricultural practices and housing. The agricultural operations ceased more than ten years ago, except for annual mowing. A small residential community extended into the western and central portion of the review area was demolished around 2003, which likely resulted in a varying amount of fill material in the area. Several small spoil piles are located along the south-southeastern review area boundary likely a result of adjacent development.

Wetland A was found to lie approximately 1,800 linear feet away from the nearest potentially jurisdictional water and does not have a surface or subsurface connection to potentially jurisdictional waters. The site lies outside of the Marion County stormwater system and does not contribute stormwater by ditch to an offsite location within the City of Salem. Based on the lack of hydrologic connectivity by stream, stormwater conveyance, or roadside ditch, the wetland does not contribute physical, chemical, or biological to a potentially jurisdictional water.
