### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Wetland D:** Wetland D is located on fill material approximately 5 feet in elevation above Wetland A, which directly abuts an RPW. There is a hydrologic surface connection between Wetland D and Wetland A during storm events. Seven (7) site visits were conducted by the consultant over a three year span. The visits occurred in July, September, February, and April. Water was observed in Wetland D during the three February site visits and was only observed flowing out of the wetland on the February 13, 2015 site visit. A site visit was performed by the Corps to assess jurisdiction on May 18, 2015. No water was observed in Wetland D. There is no defined channel between the wetlands and the observed connection was by sheet flow down the steep embankment. There are what appear to be tire ruts or scrapes in Wetland D, which were likely caused by construction equipment during the original grading of the site or by mowers during maintenance activities. The ruts collect rain water that supports FAC to OBL vegetation. Wetland D is unique in the area because it is the only known wetland that is located on perched fill material with a hydrologic connection to East Fork Dairy Creek through Wetland A. However, this connection is tenuous and limited to periods during heavy rain events. Due to the infrequent and temporary connection, the small area of the wetland, the recency of the development of wetland functions, and the lack of similar adjacent wetlands, Wetland A does not have a substantial effect on the chemical, physical, and biological integrity of a navigable waterway.

A tributary starts at this point from these headwater wetlands to East Fork Dairy Creek. The Water Quality Pond (WQP) was at one point a continuation of Wetland A. However, this portion of the wetland was converted into a stormwater pond through excavation and the creation of a berm between the WQP and Wetland A. Although the berm separates the two wetlands, there is a culvert that provides a direct hydrologic connection between the two waters and therefore does not sever the hydrologic connection to the tributary.**

**F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):**

- If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

**Wetlands B, C, and E:** Wetlands B, C, and E are considered together because they are all palustrine emergent wetlands that have formed on top of fill material. The fill material was placed between 1994 and 2000. Soils information and historic aerials indicate that the areas were likely outside of historic wetlands. The wetlands are located approximately 5 to 7 feet in elevation above Wetland A, which abuts an RPW. Each wetland is located the following distances from Wetland A: 60 linear feet (Wetland B), 150 linear feet (Wetland C), and 75 linear feet (Wetland E). No surface connection has been observed between Wetlands B, C, and E and Wetland A. Data points 10 and 14 were conducted between Wetland B and Wetland A and there is a lack of saturation and the water table. Data point 6 was collected between Wetland C and Wetland A and similarly no saturation or water table was observed. No data point was taken between Wetland E and the Water Quality pond (which was constructed in Wetland A), but it is expected that similar conditions should exist based on land scape setting. Based on this information, Wetlands B, C, and E are isolated and are not waters of the United States.

Prior to the Jan 2001 Supreme Court decision in “SWANCC,” the review area would have been regulated based solely on the “Migratory Bird Rule” (MBR).

Waters do not meet the “Significant Nexus” standard, where such a finding is required for jurisdiction. Explain: **Wetland D has an infrequent connection with Wetland A that is only present during storm events. Based on the limited functions, small size of the wetland, and infrequent (in both duration and length) of connection, Wetland D is not meet the Significant Nexus standard, see section C Significant Nexus Determination.**

Other: (explain, if not covered above): **There is a stormwater swale located on site. The swale is on the southwest portion of the property and runs from an outfall on the west of the property, to the stormwater quality pond to the east. It appears that this swale was constructed in dry land , not within hydric soils, and only receives water from the residential development located to the north and west of the subject property. The neighborhood is divided into two basins, one that drains to the west into Banks Creek, and one that drains to the east into the stormwater swale. No waters of the United States are being drained or are located up-gradient from the swale. The stormwater swale does meet wetland conditions, and was constructed in uplands for water quality treatment to meet the requirements of Section 402 of the Clean Water Act, and therefore is not a water of the United States.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetlands B, C, D, and E are all located on historic fill. Grading was completed on a portion of the site when the neighboring residential development was constructed. The subject property was also slated for development at the time, but was not developed due to the economic downturn in the mid-2000’s. These four wetlands have formed in depressions on top of compacted fill and there is no evidence of any surface or subsurface hydrologic connection with the water quality pond, Wetland A, and Wetland F. Wetlands A and F and the water quality pond are all located approximately 5 to 7 feet in elevation below Wetlands B, C, D, and E, appear to be at the natural elevation of the site, and have a direct hydrologic connection to the nearest tributary, approximately 300 feet off-site.
