Explain: The wetland onsite is a palustrine emergent wetland in the southwest corner of the project site near SE Davis Road. It extends along the western property boundary approximately 30 feet and to the east approximately 68 feet. The total area of the wetland is 0.05 acre. The wetland has hydrology because water collects throughout the project site in the southwest corner. There is a nearby offsite ditch that runs adjacent to the southern boundary. A data plot near the offsite ditch shows no

hydrology, indicating that the water from the site does not seep down to the ditch, and, therefore, there is no surface water connection. Additionally, the roadside ditch does not connect to any other waterway. During the site visit, we followed the ditch west to the intersection of SE Davis Road and SE Brookwood Ave, where it ended at a culvert that was lower elevation than across either street, indicating there was no flow possible from there (photos available). This would have been the only possible flow path to reach Gordon Creek to the south.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Therefore, the non-RPW has no significant nexus to the adjacent wetland, and the non-RPW has no significant nexus to the TNW.
