C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Five palustrine emergent wetlands (A-E) totaling 1.813 acres were delineated by Anchor QEA wetland scientists in June and July 2016. Anchor QEA returned to the site with the Oregon Department of State Lands (DSL) on May 18, 2017 and the wetland boundary was redrawn based on the presence of surface water and oxidized rhizospheres along living roots. The revised wetlands include two palustrine emergent wetlands (A and B), totaling 2.135 acres. No other waters were observed on or adjacent to the review area. Wetland A is described as a constructed trench and is bounded by a constructed berm and fill slopes. The closest mapped water is Bronson Creek and abutting wetlands, located 0.25 miles from Wetlands A and B.

Wetlands A and B do not contribute to interstate or foreign commerce. Wetlands A and B total 2.135 acres and are located in a closed depression with no connection to surface waters. The entire review area has been significantly impacted by past soil borrow activities, including scraping, grading, soil compaction, and soil stockpiling. The stockpiled soil forms the berms located in the southern portion of the study area. Additionally, a trench was excavated along the eastern boundary. The remaining area has been scraped down below the grade of surrounding parcels, resulting in a slightly depressional landscape. The primary hydrologic source for the wetlands is overland flow from the adjacent uplands within the closed depression and direct precipitation.

No streams are within or adjacent to the review area. Adjacent land use includes business parks, future high density multi-family residential development, agricultural, and wooded areas. The USFWS NWI maps and City of Hillsboro LWI maps do not show any mapped wetlands within or adjacent to the review area. Approximately 2.4 acres of the approximately 7.5 acre site are composed of hydric soils (Huberly silt loam) according to the Washington County Soil Survey. Historic aerials from 1940 show the review area as agriculture (row crops). In 2000, when the business park to the north was constructed, the aerials show the area was scraped and graded and used to stockpile soil. More recent aerials from 2007 to 2016 show mostly mowing, soil stockpiling, and grading work. Historically, the area was occupied by oak woodlands, a mosaic of prairies and oak savannah. Major alterations likely included clearing the native trees and plant communities to convert to agriculture.

The project site is located 0.23 miles from the mapped FEMA floodplain for Bronson Creek. Wetlands A and B are much lower in elevation than the surrounding uplands and road due to the historic construction activities that occurred on the site, resulting in the wetlands being approximately 10 feet below the surrounding landscape. Stormwater maps attained from the City of Hillsboro (Hillsboro Maps online mapping tool accessed 9 June 2017) indicate that there is a potential stormwater inlet adjacent Wetland A. However, the site was walked by Corps staff and no inlet was observed. There is no inflow, outflow, or drains associated with Wetlands A and B. Wetlands A and B soils are mapped as hydric.
