Explain: **The only aquatic resource in the study area is a seasonally flooded roadside ditch that meets wetland criteria (hydrology, vegetation, soils). The 0.41 acre aquatic resource is topographically isolated and does not connect with any**

downstream waterbodies. In fact, no connections, physical, chemical, nor biological, to jurisdictional waterbodies were observed during the 14 June 2017 site visit. The AJD area is bounded by upland sagebrush scrub and pasture to the north and Oregon Route 140 to the south. The wetland ditch runs along the road beyond the study area to both the east and the west. There is one culvert that allows flow from the nearby substation detention pond into the ditch. In addition, there is a culvert at the western end of the study area that allows flow off-site to the west. Approximately 0.2 miles to the east of the study area (just east of Mitchell Road), the land topography is higher than the study site and then gently slopes down to the site. Potential ditch flow into the site would come from the eastern portion of the ditch and flow west. To the west, the flow could continue off-site for approximately 0.8 miles, but would end at another area of topographical rise.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The wetland ditch is approximately 1,505 feet long by 12 feet wide. As detailed above, the ditch is isolated. There are no physical, chemical, nor biological connections to downstream waters. The ditch does not contain any fish and is seasonally dry during the summer months. There is no interstate commerce connection either: no recreational use, habitat of special significance, fish or shellfish, industrial, agricultural, or silvicultural use.

The closest named waterbody is the Lost River, approximately 3.5 miles from the study area.

A previous AJD was conducted on the pasture to the north of the study area. No waters were found at the site. Corps file number: NWP-2015-356.
