Summarize overall biological, chemical and physical functions being performed: Wetland A in conjunction with offsite wetlands across the road would provide water storage and delay, capture stormwater, sediment stabilization, phosphorus retention, nitrogen removal, wildlife habitat, and provide food chain support for the downstream creek and Columbia Slough / River.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland B-

There is one wetland (Wetland B) within the review area determined to be isolated and non-jurisdictional. Wetland B is a 0.21 acre palustrine, emergent, seasonally saturated/flooded (PEMC) wetland located in the northeast portion of the site. The topography of the site forms a depression at Wetland B. It is bordered by NW Marine Drive on a berm to the north, a berm to the east, and the project site uplands to the west and south. The wetland continues off site to the north but stops at the berm on which NW Marine Drive is constructed. The wetland is dominated by reed canarygrass, meadow foxtail, and garden bird's-foot-trefoil. Hydrology within the wetland is dominated by direct precipitation. Wetland B is a perched wetland with no visual surface connection or documented shallow subsurface connection.

In 1996 and 1997 the building to the south of the subject parcel was constructed. At that time, 6 feet of sand fill was imported onto the subject property. The sand fill tapers from 6 feet deep in the east to 3 feet deep at the west end of the property. In addition, the excavated soil from a 20 foot deep well and footings on the property to the south was spread out over the subject property. Wetland B is perched on top of at least 3 feet of this fill material.

For the past 20 years, surface water flows were directed to the northeast corner of the subject property after the Waste Management site (to the south) was constructed in 1996 and 1997. This surface water ponded in the northeast corner of the property and formed Wetland B. Recently, the City of Troutdale directed all stormwater towards Wetland A. As such, surface water is no longer present in Wetland B and the wetland is likely to dry up as no other hydrology sources are present in large enough quantities to sustain the wetland.

It is highly improbable that during a large storm event this wetland would overflow the berm to the stormwater ditch and flow into Arata Creek.

Excavated Ditch -

There is an excavated ditch onsite along the eastern property boundary. The ditch flows north into Arata Creek. The site was filled and Arata Creek was diverted to the other side of the property to the east. After fill was placed at the site, the ditch was excavated from the uplands in 1996-1997 to direct treated stormwater flow from the Waste Management facility towards Arata Creek. The ditch was purposely dug for stormwater flow from the waste management plant and functions as a waste treatment system. The ditch measures 5,286 square feet (0.12 acre). Soils at the bottom of the ditch do have indicators of hydric soils. Riparian vegetation consists of Himalayan Blackberry and reed canarygrass. The ditch has a low gradient flow and steep banks.
