- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: A 1.6-acre wetland area in the review area is a stormwater detention pond. The pond is located east of Interstate 5 (I-5) and south of SW Haines Road. It meets the three criteria (hydrology, hydric soils, and wetland plants) to be considered a wetland per the 1987 Corps wetland delineation manual, based informal determination from a site visit on May 17, 2017. However, since it was excavated from uplands and is considered a "settling basin", impacting the wetland would not be

regulated. Per the 1986 Clean Water Act Regulations Preamble (regarding Section 328.3, Definitions), several types of waterbodies are generally not considered to be waters of the U.S. and the Corps will consider their jurisdictional status on a case-by-case basis. One of the waterbody types includes “artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing”. The Portland District considers stormwater treatment facilities (swales, ponds, etc.) to be a type of “settling basin” (documented in internal guidance entitled “Non-WOUS Process June 2008”). Documentation is needed to show the pond was created in dry land and used exclusively for the listed purpose. (as long as it is not an impoundment of a tributary to a water of the U.S.). This stormwater pond meets this criteria. There are plan sheets from 1983 showing the elevation of the area where the pond was excavated. A cross section in the plans indicates the ground was excavated at 12 feet. There were no indicators of depressions, existing wet soils, wetlands, or streams in the area. These plan sheets also show the exclusive use of the pond as a “stormwater detention basin”. The pond receives its water from I-5 stormwater and the residential road network neighborhood to the east. The water then travels through storm sewers to a wetland complex just over a half mile to the west. The pond is not adjacent to or abutting a traditional navigable water or relatively permanent water. The pond was not mapped as having hydric soils by the NRCS. It was not mapped by the National Wetland Inventory but was mapped by a local wetland inventory. Aerial photographs from 1952 and 1960 show a small forested area where the detention pond is now located. Based on this evidence, it has been determined the pond is a man-made feature constructed in uplands for the sole purpose of stormwater detention.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
