Explain: **The railroad ditch, Ephemeral Channel, Wetland A, and Wetland B.**

Railroad Ditch: The railroad ditch is approximately 1,277 linear feet and has been present in its current alignment since 1936. The railroad ditch is bordered by the railroad track berm and a bluff in the residential area. The ditch begins at a stormwater outfall which conveys

stormwater from uplands in the adjacent residential neighborhood at the end of SE Boyd Street, this area is mapped in the soil survey as Latourell Loam (Non-Hydric) and Wapato Silty Clay Loam Hydric (Hydric). The majority of the rail road ditch was constructed in the non-hydric soil, while crossing through the hydric soil. The ditch is approximately 3 feet wide with an average of approximately 1-foot tall undefined banks generated by the road prism and bluff. Evidence of ephemeral flow includes presence of sparsely accumulated wrack and sparsely matted vegetation which was not continuous throughout the ditch. There was a lack of a clear Ordinary High Water Mark through the length of the railroad ditch. The railroad ditch substrate consists of angular cobbles and is lightly vegetated with English plantain, field meadow-foxtail, and Himalayan blackberry. The railroad ditch is not a channelized stream nor does it connect two waters of the United States. Due to this information the railroad ditch is considered to be a non-water of the US.

Ephemeral Channel: The vegetated ephemeral channel is approximately 56 linear feet ditched channel, approximately 1-foot-wide by 1-foot deep by 56 feet long. The channel conveys stormwater runoff into Wetland A through a culvert under SE Oak Street from a grated intake on the east of SE Oak Street. The channel was dug in upland non-hydric soils. No flow was present within this channel during the April 18, 2017 site visit conducted by the consultant. There was no clear Ordinary High Water Mark within the channel. The ephemeral channel was dug in uplands for the conveyance of stormwater flow from Oak Street. The ephemeral channel is not a channelized stream nor does it connect two waters of the United States. Due to this information the channel is considered to be a non-water of the US.

Wetland A: Wetland A is 403 square feet palustrine emergent wetland located at the southeastern end of the study area. The area is mapped as a non-hydric soil (Woodburn silt loam). The wetland is located in a concave depression. The ephemeral channel is the main source of hydrology for Wetland A. Wetland A is surrounded by impervious surface and there is no outflow culvert or location for flow to go. The wetland is not located within the floodplain. Spring Creek is the nearest Water of the United States and is located approximately 0.34 miles away. During extreme flood events it is unlikely that that this wetland would overflow into the nearest Water of the U.S. The land between the wetland and Spring Creek is completely developed by commercial and residential developments.

Wetland B: Wetland B is 283 square feet palustrine emergent wetland west of SE Balfour Street, in the southern portion of the study area. The area contains mapped hydric soils (Wapato Silty Clay Loam). The wetland is located in a concave depression. The railroad berm runs parallel to the wetland to the west and a bluff is located to the east. Wetland B hydrology is received primarily through hillside runoff and there was no evidence of outward flow from the wetland. The surrounding area is mapped Latourell Loam (Non-Hydric and Urban Land (Non-Hydric)). The wetland is not located within the floodplain. Johnson Creek is the nearest Water of the United States and is located approximately 0.42 miles away. During extreme flood events it is unlikely that that this wetland would overflow into the nearest Water of the U.S. The land between the wetland and Johnson Creek is completely developed by industrial developments.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
