C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The parcel is located within the Gilbert Creek-Rogue River watershed (HUC12: 171003080402). The study area taxlot is located in the urban area of the city of Grants Pass with primarily residential land uses occurring within the vicinity of the taxlot. Vegetation in the area is dominated by abandoned pasture and landscaping. Aerial imagery, the National Hydrography Dataset, and Topographic maps detail the location of the nearest waters of the United States which is the nearest traditionally

navigable water the Rogue River. The Rogue River is approximately 0.51 miles away. LiDAR and Aerial imagery indicate there is no direct or indirect connection to the subject parcel.

The LWI notates wetland at the southern end of the property (sampling points 4, 5, and 6). Due to abutting development and changes in irrigation the area no longer exhibits wetland characteristics.

NRCS Soil mapping indicates the soils within the study area are Barron coarse sandy loam, 2-7% slopes which is somewhat excessively drained; slow runoff; moderately rapid permeability and hydric.

The FEMA FIRM map indicates the study area is located in an area of least flooding concern and is outside of the 100-year floodplain (Zone X).

Additional information from the consultant discusses remnant features of irrigation ditches on the parcel. One irrigation ditch, which is still intact, is concrete lined and unused. The other ditches were earthen and have not been maintained and have filled back in to the point they no longer could carry irrigation water. No irrigation water is supplied to the parcel at this time.

The concrete-lined ditch does not carry water during the wet season, as it is no longer connected on the south end to any outlet/source. The surrounding lands have their own stormwater drain system, as they are developed as modern residential neighborhoods which has reduced the hydrological contributions to the concrete ditch. Therefore, there is no stormwater source to fill the concrete ditch and with no water source, it does not carry water during the wet season. Photos of the concrete ditch were not taken by the consultant in February, but during the consultant's site visit it did not exhibit standing or flowing water.
