### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

One onsite wetland was determined to be isolated, with no substantial nexus to interstate commerce. The wetland does not have a significant nexus to Waters of the US.

The wetland is located on a site within a moderate density residential development, with existing single family residences to the north and west. The wetland is situated on a small terrace within the site. A single family house sits on the ridge above the wetland.

Wetland A is an emergent wetland onsite measuring 838 square feet (0.02 acres). The wetland originates at the base of a steeply sloped area along the western edge of the property and continues out onto a terrace. The source of the wetland hydrology appears to be a seep discharging at the ground surface of the terrace at the base of the hillslope. A piped source of hydrology was not located during a site visit. Wetland vegetation is dominated by reed canary grass (*Phalaris arundinacea*) with creeping buttercup (*Ranunculus repens*). Wetland soils met the redox dark surface (F6) hydric soil indicator. Wetland hydrology indicators included soils that were saturated to the surface and had a depth to free water of 12 inches below the ground surface. Scattered areas of shallow surface ponding were also present in the wetland. Hydrology is likely to go subsurface at the point where the topography begins to slope downward toward the east. The wetland does not continue down the hill as it slopes toward the creek. Wetland hydrology, soils, and plants were not located between the wetland and down the slope toward the creek. The soils at the site are mapped as Cascade silt loam with 8-15% slopes and 15-30 % slopes. These silt loams are "somewhat poorly drained; slow to rapid runoff; slow permeability". An unnamed tributary to Arnold Creek is located offsite of the property at the bottom of the slope. The tributary leads to Arnold Creek, to the Willamette River. Arnold creek is located greater than 200 feet north of the site (across property boundaries), and an unnamed tributary to Arnold Creek is located greater than 100 feet to the east of the site (across property boundaries).

Surrounding uplands consist of mainly deciduous forest dominated by big-leaf maple (*Acer macrophyllum*), with three remnant large diameter Douglas Fir (*Pseudotsuga menziesii*) trees located along the western property boundary. Understory is fairly open with sparse cover of native shrubs, mostly beaked hazelnut (*Corylus cornuta*) and oso-berry (*Oemleria cerasiformis*). An area of Himalayan blackberry (*Rubus armeniacus*) is present in the area closest to the road. Blackberry and English Ivy comprise nearly 100% of the groundcover.
