Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: The channel begins at the outfall of a stormwater culvert on the south end of Reese Road, continues south through adjacent residential property, and ends at a culvert inlet at the Union Pacific railroad embankment. Residential property begins about 20 feet south of the outfall. The culvert under the railroad continues south under Lakeview Boulevard and Lake Grove Park to an outfall in the park. The drainage does not continue through the park to Oswego Lake. The channel

disappears after getting to the park. The total length of the channel is approximately 440 linear feet. The channel has a steep gradient and is lined with riprap, asphalt fragments, and small rock. It occupies a deep gully at first and then spills out onto an open slope. All water entering the system originates from stormwater, and no natural drainage ways or waterways input additional hydrology to the channel above the outfall. Stream flow duration was determined using direct observation of flow combined with rainfall data and the protocol in Streamflow Duration Assessment Method for the Pacific Northwest (USEPA, Nov 2015). Please refer to the Streamflow Duration Assessment Report dated March 22, 2017 prepared by WHPacific (in project file). The report concludes the channel has ephemeral flow signified by absence of aquatic macroinvertebrates and wetland plants. This is corroborated by direct observations of flow duration. The Corps does not generally assert jurisdiction over swales or erosional features with low volume, infrequent, or short duration flow. This channel fits this criteria. This information was verified by the Corps in the field on August 24, 2017.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
