Explain: **Two wetlands (Wetlands A and B) and two lined open water hazards (Water Hazards 1 and 2) are located within the review area (the eastern portion of a maintained golf course, as shown on the attached drawings). No**

hydrological connections, nor biological or chemical connections, have been observed between these on-site water hazards and wetlands, and any downstream waters. According to stormwater drawings, there is an inlet culvert located at each wetland. These culverts are at higher topography than the wetlands and would not create any opportunity for discharges from the wetlands, even during storm events. No outlets have been observed for any waterbody other than connections to each other (and irrigation pump houses). The two wetlands are located in areas of lower topography than the surrounding areas and both connect across golf cart paths to the southernmost open water feature, Wetland A from the west and Wetland B from the east. The wetlands appear to collect surface water from the surrounding uplands and culverts. According to the golf course grounds manager, water is pumped from a pump house to the west of the southern open water hazard, around the southern edge of the feature and into it at its east end. Water from the southern open water hazard is piped under the course to the northern open water hazard. Water from the northern open water hazard is pumped out for course irrigation. No other potential connections between or in/out of the waters have been observed. The on-site water hazards and wetlands are approximately 868 feet from the nearest waterbody, Dodson Slough (a perennial stream), which is located south of the golf course. Over this distance, both topographical and other physical barriers (i.e., a road) separate the waters. There is no potential for waterbody use by interstate or foreign travelers for recreational purposes. The site is a privately-owned golf course and use is limited to golfing in the upland portions of the site. There are no habitat or resources of special significance which would attract interstate or foreign travelers, nor are there any bird or wildlife species of special significance which would attract interstate or foreign travelers. There are no fish or shellfish which could be taken or sold in interstate or foreign commerce. There is no agriculture or silviculture at the site. Please see sections IV.B. below for additional site details.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site is a currently used, maintained golf course consisting of mainly upland, open areas, with smaller upland forested areas mostly in the northern portion of the review area. The on-site water hazards are used for site irrigation. The wetlands connected to Water Hazard 1 formed in depression areas that collect runoff from surrounding uplands.

According to the NRCS Soils Survey, site soils consist of Camas gravelly sandy loam, Coburg silty clay loam (considered hydric), Courtney gravelly silty clay loam (considered hydric), Fluvents (considered hydric), Pits, and Salem gravelly silt loam.

A constructed bioswale is present for stormwater capture along the Delta Highway in the southwestern portion of the review area. No aquatic features have been observed to connect to this swale, nor is this swale a wetland or any other waterbody.

On June 13, 2017, the Corps coordinated this JD with EPA Region 10 and Corps HQ. Neither the EPA nor Corps HQ provided any response within the required timelines.
