2. **Characteristics of wetlands adjacent to non-TNW that flow directly or indirectly into TNW**

(i) **Physical Characteristics:**

(a) General Wetland Characteristics:

Properties:

Wetland size: 1.58 acres

Wetland type. Explain: Palustrine Emergent Wetland which has historically been farmed, grazed, and is currently under direct pressure of being an open space between buildings on a University Campus.

Wetland quality. Explain: The wetland is a low quality due to the lack of wet prairie characteristics of vegetation and is a highly manipulated site.

Project wetlands cross or serve as state boundaries. Explain: No, the wetland does not cross or serve as a state boundary.

(b) General Flow Relationship with Non-TNW:

Flow is: **Ephemeral flow**. Explain: Flows from the wetland vary with the winter. The soils get saturated and prevent further penetration due to their slit loam texture. Once the soils are saturated, the wetland flows towards the west and northwest corner at Madison and 8th Street where it flows into the storm drains. When high rainfall events occur, the site retains some of the rainfall and then slowly releases it to the stormdrain along the street.

Surface flow is: **Overland sheetflow**

Characteristics: The sheetflow is apparent in an on-site photo from the applicant, Google Earth Street view which reflects how flat the site is, and an on-site visit also documented the sheetflow across the pedestrian path and into the street where it was collected by stormdrains.

Subsurface flow: **Unknown**. Explain findings: Subsurface flows were evident from the sidewalk not showing signs of water crossing the surface, but were evident in the slope below and flowing over a curb, down the street and into a gutter.

Discrete wetland hydrologic connection. Explain: The wetland is fairly flat and the flows from the wetland appear to be sheetflow over and under a sidewalk and into a stormdrain. There is a sidewalk around the perimeter edge, however the flow from the wetland has been observed flowing over the sidewalk and into the street and the stormdrain. The site visit MFR from 03/23/2018 documents the flows observed while on-site.

Identify specific pollutants, if known: Specific pollutants from nearby activities include oil and heavy metals from motor vehicles commuting to and from OSU campus and the lawn mower used by OSU to mow the vegetation at the site. Other sources come from trash and debris thrown on the ground by students. No other point source contaminants have been observed.

Summarize overall biological, chemical and physical functions being performed: The wetland performs chemical treatment of stormwater and other airborne contaminants from human activities. Other physical functions include detaining stormwater on-site and minimizing flooding downstream in the Willamette River which directly affects areas directly downstream, such as Portland.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The wetland would be considered as abutting the non-RPW if the stormwater drain was on the same grade as the wetland, but since the flows have to come over the sidewalk and down the curb, the wetland is considered adjacent. There is no rise in topography to suggest the wetlands cannot flow into the stormdrain more frequently. On rainy days it is difficult to discern where all flows on the sidewalk and in the stormdrain are coming from.
