Summarize overall biological, chemical and physical functions being performed: **Wetland 1** is a palustrine emergent wetland approximately 0.43 acres in size located along the north portion of the review area on tax lot 800. Wetland vegetation is dominated by reed canarygrass (*Phalaris arundinacea*) with meadow foxtail (*Alopecurus pratensis*) in the upslope portion. Wetland soils were saturated to the surface or shallowly ponded across the entire wetland, as observed during the March 27, 2018 site visit and noted in the wetland delineation for hydric soils and as a hydrology indicator. An undefined shallow channel flows west to east through the center of the wetland and is mapped on the National Wetland Inventory as a riverine stream. Wetland 1 extends offsite to the north and west of the tax lot boundaries. Hydrology from the wetland and channel extend offsite to the east via a roadside ditch and culvert beneath NW Kansas City Road. A large palustrine emergent wetland and an unnamed tributary to Lousignont Canal-Hill Drainage District 7 Ditch intercept Wetland 1 flows east of NW Kansas City Road. **Wetland 2** is a small palustrine emergent roadside wetland approximately 0.004 acre, adjacent to the southeast corner of tax lot 900. Wetland 2 flows onsite from the south via a 12-inch culvert located under a private driveway and extends 70 feet north where it enters a culvert flowing east under NW Kansas City Road. Wetland 2 flow is intercepted by the same large palustrine emergent wetland and tributary to Lousignont Canal as Wetland 1. Wetland 2 is dominated by fringed willowherb (*Epilobium ciliatum*), lamp rush (*Juncus effusus*), and curly dock (*Rumex crispus*). Wetland 2 soils were saturated to the surface with a depth of 12 inches.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The subject site is located in an unincorporated area of Washington County with adjacent rural residential and agricultural land use. The site contains an existing residence on tax lot 800 that is planning the relocation of their dwelling onto tax lot 900. Tax lot 900 contains an existing residence and several outbuildings and is currently in agricultural use as a wheat field. The closest tributary to the subject site is an unnamed tributary to Lousignont Canal located east of NW Kansas City Road. Elevation of the site slopes down gradually from 190 feet above sea level in the central portion of the site to 180 feet above sea level in the southeast and northeast portions of the site. Some brush clearing occurred recently around the existing house on tax lot 800. No recent site alterations have occurred onsite. Tax lot 900 has been in agricultural land use for many years, and it was plowed and planted to a wheat crop last fall.
