This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

During storm events there would be no overflow to the nearest water of the U.S. Water leaves the site through a subsurface pipe and therefore has little capacity to transfer nutrients and organic carbon to support food webs, does not provide habitat services such as spawning areas, and does not provide sediment trapping. Pond C and its relevant reach does not have more than an insubstantial or speculative effect on the biological, chemical, or physical integrity of the nearest RPW Waterhouse Creek, or the nearest TNW the Willamette River. Therefore, Pond C does not have a significant nexus with the TNW.

Explain: **Pond C is not an RPW because it does not flow continuously for 3 months out of the year. Pond C has a rapid draw down rate, empties quickly, and stops flowing within a few days after a storm, therefore, during storm events there would be no overflow the nearest water of the U.S. There isn't much baseflow, if any. The flow comes from impervious surfaces and partly from the ball fields under drains. The water from Pond C discharges through a culvert on its western edge to travel 1,376 feet through subsurface pipes the entire way to Waterhouse Creek, the nearest RPW. Pond C and its relevant reach does not have more than an insubstantial or speculative effect on the biological, chemical, or physical integrity of the nearest RPW, or the nearest TNW the Willamette River. Therefore, Pond C does not have a significant nexus with the TNW. See also Section III. C. 1.**
