C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

It would have the capacity to transfer nutrients and organic carbon that support downstream foodwebs. It has a physical connection to the Tualatin River.

Wetland D is connected by groundwater to the nearest RPW which is Tributary 1 that flows into the Tualatin River. These wetlands in combination contribute to reducing the amount of pollutants and flood waters reaching the Tualatin River. They provide habitat and life cycle functions for species that are present in the Tualatin River. They have the capacity to transfer nutrients and organic carbon that support downstream woodwebs.

Wetland C (0.01 acre) is PEM/PFO and is located west of Wetland B and north of the stream. Hydrology is provided mostly by groundwater discharging near the toe of slope. The wetland is within the review area only and is connected to the stream. Total is 0.04 acre.**

Provide acreage estimates for jurisdictional wetlands in the review area: **Wetland A (0.29 acre) is a palustrine emergent wetland located in the northeast corner of the site and continues off-site to the north of the review area. It is adjacent to a tributary near the headwaters for the stream on the Roshak North site and mitigation project to the north. It connects to the wetland immediately north through a culvert and water control structure in River Terrace Blvd just north of the property line. Wetland E (0.03 acre) is a palustrine emergent wetland and located east of Wetland D. It is confined in a ditched depression and drain tiles outlet into the south end of the wetland. Drain tile water flows into an 8-inch aluminum pipe at the northern end of the wetland and outlets into Wetland D. Wetland D (0.18 acre) is a palustrine emergent wetland located near the center of the site and was formerly an irrigation pond which was drained in October 2018. Hydrology is provided by groundwater surfacing at the toe of slope - Total 0.5 acres.**
